SUMMARY OF INFORMATION

THERE ARE TWO AGENDAS BEING ADDRESSED AT THIS MEETING. ONE IS RATHER OPEN AND ABOVE BOARD, THE OTHER IS VERY SECRET AND MUST BE KEPT HIDDEN FROM THE PUBLIC AT LARGE. THIS HIDDEN AGENDA CONSISTS OF A SECRET AGREEMENT OF COOPERATION BETWEEN TWO PARTIES THAT ARE KNOWN TO BE IN OPPOSITION TO EACH OTHER. THESE TWO PARTIES ARE DIVIDED BY A WALL OR BARRIER OF SOME SORT. ALTHOUGH THERE MAY ACTUALLY BE A PHYSICAL BARRIER, THE REAL SEPARATION BETWEEN THESE TWO PARTIES IS IDEOLOGICAL OR POLITICAL DIFFERENCES. THIS MEETING IS CONDUCTED BY HIGH-RANKING REPRESENTATIVES OF EACH OPPOSING PARTY.
