1. (S/NF/SK) TASKING: The Interviewer was knowledgeable of the

locate this person and provide as much personalia pertaining to him as possible. The Source, however, was provided no targeting data except a set of encrypted coordinates as per Extended Remote Viewing (ERV) protocols, to preclude inadvertent geographic cuing. No other cuing or descriptive data was provided to the Source. In this session, Source was targeted against the material located in an envelope marked #1, which remained in the possession of the Interviewer throughout the session.

2. (S/NF/SK) Prior to the session, an examination of the data in the envelope found that the envelope was empty and the actual personalia on the target personality had been misplaced during a previous session with another Source. It was believed that since the target was the actual person and not the envelope, the absence of the actual personalia was only a technical problem and should have had no affect on the information provided in the session. During the actual session there were no other reportable anomalies or incidents which may have affected or influenced the data provided by the Source. Only ERV protocols were utilized in the conduct of this session.

3. (S/NF/SK) SUMMARY:

a. (S/NF/SK) Information provided by Source could not be readily correlated to the target personality. Some data was ambiguous which other information was of a nature that it could be reasonably certain that it had no direct association with the

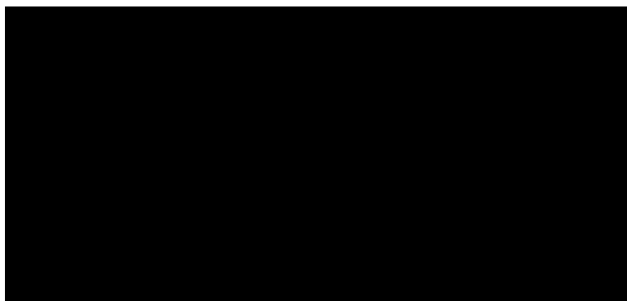

target personality.

b. (S/NF/SK) All material concerning this session, i.e., Source notes, sketches, Interviewer notes, etc., are maintained in the mission field dossier at this location.

4. (S/NF/SK) OPS FEEDBACK: This was the first ERV session conducted with this Source in several weeks. That fact coupled with the technical problem of the "empty envelope" may have been factors resulting in the failure of this session. In the next session, it is planned to utilize another envelope containing another personality, so that the question of the empty envelope will no longer be factor. Additionally, the use of a new target will provide the Source with a fresh goal in which to focus His perceptions.
