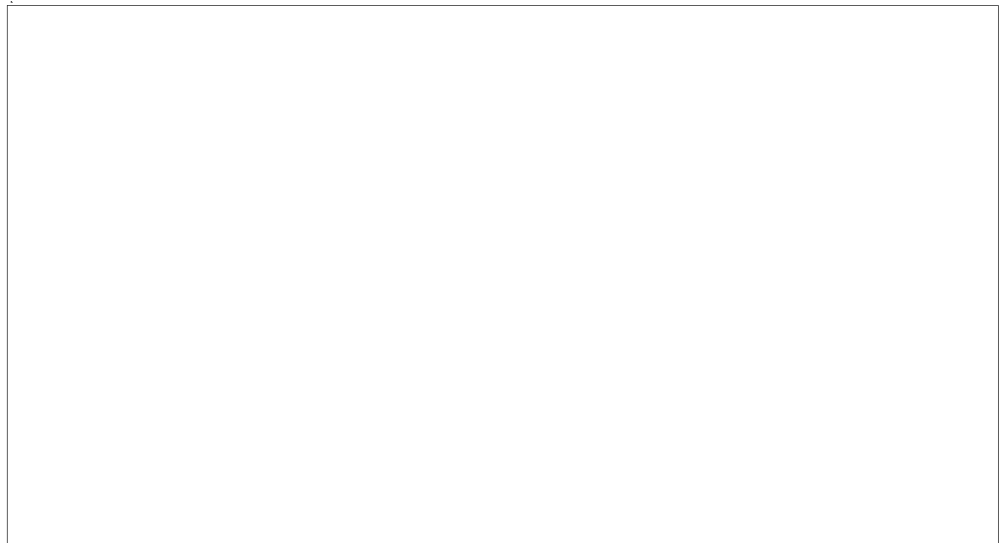

(S//NF) 1. THE CUBAN GOVERNMENT HAS ASSIGNED THE HIGHEST PRIORITY TO EFFORTS OF THE CUBAN DELEGATION TO THE UNITED NATIONS HUMAN RIGHTS COMMISSION IN GENEVA TO AVOID CONDEMNATION OF HUMAN RIGHTS ISSUES. THE CUBAN DELEGATION, HEADED BY **RAUL ((ROA)) KOURI**, A VICE MINISTER OF THE MINISTRY OF FOREIGN RELATIONS (MINREX), WILL HAVE THE FULL SUPPORT OF THE CUBAN GOVERNMENT IN TERMS OF THE CALIBRE OF ITS PERSONNEL, LOGISTICS AND TECHNICAL SUPPORT.

(S//NF) 2. A MINISTRY OF INTERIOR (MININT) CONTINGENT WILL ALSO TRAVEL TO GENEVA FOR THE MEETINGS. THIS CONTINGENT WILL BE ARMED WITH EXTENSIVE FILE INFORMATION ON THE CUBAN WITNESSES EXPECTED TO BE CALLED BY THE COMMISSION. MININT WILL ATTEMPT TO PLACE BEFORE THE COMMISSION DEROGATORY INFORMATION ON THE WITNESSES GATHERED BY MININT IN CUBA IN ORDER TO DISCREDIT THE WITNESSES AND DEVALUE THEIR TESTIMONY.
