ORIGINAL AGREEMENT AMONG ARGENTINA, URUGUAY, CHILE, BOLIVIA, AND PARAGUAY TO COOPERATE TO EXCHANGE INFORMATION ON TERRORISM AND SUBVERSION, IT HAD NOT YET AGREED TO PARTICIPATE IN CONDOR ACTION OPERATIONS IN EUROPE, AND WOULD LIMIT ITS CONTRIBUTION FOR THE TIME BEING TO THE PROVISION OF COMMUNICATIONS EQUIPMENT FOR CONDORTEL, THE COMMUNICATIONS NETWORK ESTABLISHED BY THE CONDOR COUNTRIES.
