OFFICIAL TO THE JCR DELEGATES AT THE CONFERENCE AS THE INDIVIDUAL WHO WOULD TAKE RESPONSIBILITY FOR THE DEVELOPMENT OF THE JCR LOGISTICAL STRUCTURE. THE JCR DISCUSSED PLANS FOR THE EXPANSION OF THE REVOLUTIONARY STRUGGLE OVER ALL OF SOUTH AMERICA, AND IN THIS CONNECTION NOTED THAT THEIR MOST SERIOUS PROBLEM WOULD BE LOGISTICAL SUPPORT. IT WAS ALSO NOTED THAT THE INDIVIDUAL RESPONSIBLE FOR THE JCR'S SUPPORT NETWORK SHOULD BE AN EXPERIENCED AND WELL QUALIFIED SPECIALIST.
