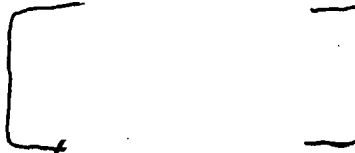

ACTION REQUIRED - REFERENCES EGFW-16524 dated May 1964			
<p>1. On 21 May, CARAVEL advised <input checked="" type="checkbox"/> the anticipated revamping of IDEN 1 (SG) foreseen for March had only partially been achieved. The following changes, respectively corrections of reference statements, should be noted:</p> <p>a. The correct title of IDEN 2 (BRUECKNER) is IDEN 3 (Leitender Kriminalprokurator).</p> <p>b. The correct title of IDEN 4 (PAAR) is IDEN 5 (Oberregierungsrat).</p> <p>c. IDEN 6 (EIRING), IDEN 7 (Assistant for Administration) has retired.</p> <p>d. IDEN 8 (KUGLER), IDEN 9 (Personnel) has become IDEN 6's replacement as IDEN 7. No replacement for the post vacated by IDEN 8 in IDEN 9 has been named so far.</p> <p>e. The position formerly held by IDEN 10 (PETERS) is still open.</p> <p>2. CARAVEL reports that he was offered the position of IDEN 11 (RADKE), IDEN 12 (reputy Chief, BtV) whose retirement is scheduled for 30 September 1964. He declined on the grounds that he did not consider himself qualified for the position as all of his training and experience was in IDEN 13 (Police Work) and the IDEN 14 (C/E) field was foreign to him. The position was offered to IDEN 2, head of IDEN 1 during the week of 19 May 1964. According to CARAVEL, IDEN 2 is actively considering the offer and will give his decision next week. CARAVEL talked as if the loss of IDEN 2 as head of the IDEN 1 was a foregone conclusion. He had no idea as to who might replace IDEN 2 in IDEN 1.</p> <p>3. CARAVEL reiterated some bitter comments on the IDEN 15 (Silberstein) report to the IDEN 16 (Bunderlag) on the "ABHOER" Affair. He stated that IDEN 11 now goes into retirement having been branded by IDEN 15 as "an unqualified official". CARAVEL opined he would never have accepted IDEN 17's (HOEBHERL'S) advice to IDEN 11 to do nothing about IDEN 15's unjustified evaluation.</p>

"in the interest of harmony". This despite the fact that as CARAVEL states, the IDEN 15 report to the IDEN 16 is more or less being buried and having served its' purpose, will not be heard of anymore. CARAVEL's reiteration of this undoubtedly reflects his continuous and subjective concern for the effect upon German security organizations of any, and all events and incidents which affect their personnel. It reflects his particular sensitivity to the results of the current war crimes trials in Frankfurt and other government courts and the question marks they raise with regards to the possible past affiliation of senior personnel in these security organizations with organizations and activities during the Nazi regime.
