Were we in a position to advise UTILITY we would suggest to him that such a fairly obvious tie would best be admitted by UTILITY to GRENGUIF-1 on the basis of old friendships between NUELLER and one of his Field Staff personnel (@ MRIER) which UTILITY would be willing to assure GRENGUIF-1 would never be exploited to the detriment of internal Austrian interests.
