A. [REDACTED] CALLED AT [REDACTED] HOTEL ROOM IN MOSCOW IN EARLY MORNING JANUARY 28 AS [REDACTED] WAS PACKING TO LEAVE FOR AIRPORT AND DEPARTURE FROM USSR. [REDACTED] ASKED [REDACTED] TO DELIVER MESSAGE TO PERSON WHO WOULD RESPOND TO TELEGRAM THAT [REDACTED] WAS TO SEND WHEN HE RETURNED TO LONDON.

B. SUGGESTED TELEGRAM BY [REDACTED] WAS "PLEASE MEET ME ON (TIME AND PLACE WAS TO BE PROVIDED BY [REDACTED]). SIGNED ANDY." [REDACTED] DOES NOT RECALL THE TELEGRAPHIC ADDRESS.

C. MESSAGE TO BE DELIVERED TO PERSON WHO RESPONDED TO [REDACTED] TELEGRAM WAS IN RUSSIAN AND AS FAR AS [REDACTED] CAN RECONSTRUCT AS FOLLOWS: "BE CAREFUL BECAUSE AUTOMOBILE WITH LICENSE NUMBER [REDACTED] CANNOT RECALL TAG NUMBER) IS FOLLOWING YOU AND THEY ARE WATCHING YOU ALL THE TIME NOW."

D. [REDACTED] MADE NOTES. HOTEL PORTER INTERRUPTED FURTHER CONVERSATION. AT AIRPORT [REDACTED] TOLD [REDACTED] HE REFUSED TO CARRY OUT [REDACTED] REQUEST AND DESTROYED NOTES. [REDACTED] WAS STUNNED AND UPSET BY THIS ACTION WHEREAS PREVIOUSLY IN EBULLIENT SPIRITS.

[REDACTED] COCKTAIL PARTY FOR PAPER DELEGATION WAS ARRANGED BY [REDACTED] AFTER MUCH PRESSURE BY [REDACTED] FOR EITHER BRIT OR AMER EMB TO THROW SUCH PARTY WITH REQUEST THAT BRIT EMB REP (PRESUMABLY DR. SENIOR) SHOULD BE AT PARTY IF AT AMER EMB. (COMMENT: THIS CLEARLY ATTEMPT BY [REDACTED] TO TRANSMIT WARNING TO US THAT [REDACTED] BEING SURVEILLED).

2. IT CLEAR THAT TELEGRAPHIC ADDRESS WAS LABORICI AND THAT [REDACTED] HAS NOT MADE MEETS BECAUSE OF SURVEILLANCE ON [REDACTED] SIGNATURE ANDY WAS FAULTY MEMORY [REDACTED] AND LIKELY WAS ALEX.

3. [REDACTED] INFORMED [REDACTED] THAT HE HAS ALREADY APPLIED FOR VISA TO VISIT WORLD'S FAIR IN SEATTLE. SAID HE WOULD ALSO VISIT AUTO SHOW SWITZERLAND. (COMMENT: 32ND INTERNATIONAL MOTOR SHOW BEING HELD GENEVA 15 TO 25 MARCH.)

4. IN VIEW POSSIBILITY, HOWEVER REMOTE, THAT [REDACTED] MAY DISCUSS THESE EPISODES WITH SOME UNAUTHORIZED PERSON, WE PLAN GIVE HIM SECURITY BRIEFING SATURDAY MARCH 10. SINCE [REDACTED] UNDER SUSPICION BY SOVS, AND TO AVOID [REDACTED] BLOWING THESE EPISODES TO SOVS (SHOULD THEY EVER HOLD AND QUESTION HIM) AS EXAMPLE OF SOV PROVOCATION, WE FEEL WE MUST WARN [REDACTED] THAT THIS INFO WHICH HE HAS GIVEN [REDACTED] IS OF INTEREST TO US AND HE MUST NEVER REFER TO IT. [REDACTED] PLANS LATE APRIL - EARLY MAY VISIT MOSCOW.

A. TO INSTRUCT [REDACTED] TO CONTINUE VISITING PARK AND SHOPS BUT AT DIFFERENT DATES AND TIMES BUT NOT AT DATES AND TIMES OF SCHEDULED MEETS. THIS TO AVOID SOV SPECULATION AS TO SUDDEN STOPPAGE IF [REDACTED] DOES NOT GO OUT AT ALL.
