1. REPORTS FROM FIELD INDICATE COURTES CAPITALIZED ON US ROSENBERG  
SPY CASE AND ATTEMPTING CONVICTS PUBLIC ROSENBERG VICTIMS ANTI-SEMITISM  
AND NOT GUILTY.

2. IN ANSAS WERE RECREATION OF THIS CAMPAIGN WERE NECESSARY SUGGEST  
MEDIA WERE FOLLOWING LINES:

A. CHARGES ROSENBERG VICTIMS US ANTI-SEMITISM WHOLELY RIDICU-  
LOUS SINCE TRIAL JUDGE SAMUEL HANFMAN; PROSECUTOR, IRVING SAYPOL;  
ASSISTANT US ATTORNEY, ROY M. COHN, JAMES MILDENBERG; AND SUPREME  
COURT JUSTICE MELVIN FRANKFURTER, WHO RENDERED FINAL COURT DECISION,  
ALL ARE SEMITES.

B. COMPARISON LENGTH OF LITIGATION IN ROSENBERG CASE AND JUDI-  
CIAL SAFEGUARDS AVAILABLE TO THEM WITH USUALY TREATMENT OF FRAGILE  
DEFENDANTS WHO HELD PRESIDENTIALLY WITH NO VERDICT APPEAL. FRAGILE  
DEFENDANTS FORCED TO DECLARE BELIEVE GUILTY AND TESTIFY AGAINST BELIEVE  
WHILE ROSENBERGS ASSURED BY US COURTS DISCRETION UNTIL PROVED GUILTY.  
ROSENBERG CASE HAD THREE SEPARATE HEARINGS AND FOUR APPEALS CONSIDER-  
ATION IN SUPREME COURT REVIEW. THE WHOLE PROCESS LASTED FROM  
31 JANUARY 1951 WHEN THEY INDICTED BY NEW YORK GRAND JURY UNTIL 1954.

C. REASON COURTS EXERCISED SAFES OVER ROSENBERGS BASED ON  
FACT BOY NEW YORK CONGRESS MEMBER AMAROLI A. YANOVICH INVOLVED IN  
CASE AS MAN WHO GOT SWEDISH DOCUMENTS AND NOT ON ANY INTERNATIONAL  
INTEREST ROSENBERGS. COURTS TRYING CREATING IMPRESSION ROSENBERGS  
THROUGHT TO OBTAIN THIS ADDITIONAL EVIDENCE BOY UNION REBANKED ON  
WORLD-WIDE SUSPECTIVE CONSPIRACY WHICH ALREADY REACHED SWEDISH, GREEK  
AND CANADIAN SPY TRIALS.

D. ROSENBERG CASE TESTIMONY TO FACT THAT COMMIE PARTY MEMBERSHIP  
MEANS INDIVIDUAL HAS SOLD HIS SOUL TO A FOREIGN POWER AND IS DEDICATED  
TO BETRAYAL OF OWN COUNTRY. THIS POINT CAN BE MADE IN CONJUNCTION WITH  
LOCAL ROSENBERG COURT LEADERS TOWERS MOSCOW LINE TO INTEREST OF OWN  
NATIONAL INTERESTS.

3. BACKGROUND ON ROSENBERG CASE IS AS FOLLOWS:

A. ROSENBERGS INDICTED 31 JANUARY 1951 BY NEW YORK GRAND JURY  
UNDER US ESPIONAGE ACT OF 1917 ON FOLLOWING CHARGES, "ON JUNE 6, 1944  
TO JUNE 16, 1950 THE DEFENDANTS, HERRSH DID, THE UNITED STATES OF  
AMERICA THEN AND THERE BEING AT WAR, CONSPIRE, CONSIDER, CONFEDERATE  
AND AGREE WITH EACH OTHER ... TO VIOLATE ... UNITED STATES CODE, IN  
THAT THEY DID CONSPIRE, CONSIDER, CONFEDERATE AND AGREE, WITH INTENT  
AND REASON TO BELIEVE THAT IT WOULD BE USED TO THE ADVANTAGE OF A

FORNICE RIGHTS, TO KEE, THE BIRTH OF SOVIET SOCIALISM IN RUSSIA, TO  
DISMEMBER THE BARRIERS TO A MODERN GOV. SYSTEM, TO WAT, THE  
RATION OF SOVIET HONORABLE DEATHS, AND REPRESENTATIVE AND IDEALS  
WORLDWIDE, DIGNITY AND HUMANITY, HUMANITY, HUMANITY, HUMANITY, HUMANITY  
AND HUMANITY RELATED TO THE HUMANITY. HUMANITY OF THE UNITED STATES  
OF AMERICA."

B. ROSENBERG REMAINED NOT CONVICT AND TRIAL FROM PAGE 6, 1951.  
DAVID ROSENBERG, ALSO MENTIONED WITH ROSENBERG, REMAINED CONVICT AND  
DEFENDED FOR GOVERNMENT ON TRIAL OF JUDGMENT. TESTIMONY AS TRIAL  
PROOF OF ROSENBERG'S OBTAINED FROM GOVERNMENT AND OTHERS FURNISHED  
BY THEM FOR SOVIET PROPAGANDA DESTRUCTIVE MATERIAL, AND (MATERIAL) OF AMERIC  
FOUN AND OTHER MILITARY EQUIPMENT. TESTIMONY ESTABLISHED THIS INFO  
WAS PASSED TO USSR THROUGH YANOVSKY, USSR NEW YORK CONSUL, RUSSIA.

C. JURY FOUND ROSENBERG GUILTY AND HAVE NO PROTECTIVE SERVICES FOR  
LIFE. JURY HAD BEEN INFORMED THAT TO LIVE AS LONG AS AGE 1947  
MAYBE WITH AS HUMANITY SERVICE FOR DESTRUCTION IN RUSSIA.

D. THREE HEARINGS AND FOUR APPEALS LATER CASE CASE FOR, SEVEN TO  
SEVEN COURT WITH UNHELD COST OF APPEALS REFUSAL TO REVERSE GUILTY  
VERDICT.

E. ON SUBSEQUENT ROSENBERG, JUDGE HANFMAN MADE FOLLOWING STATE-  
MENT, "IT IS IRONIC THAT THE VERY COUNTRY THAT THESE DEFENDANTS HAVE  
COMMIT TO DESTROY HAS PLACED EVERY SAFEGUARD AROUND THEM FOR CERTAINLY  
A FAIR TRIAL. I RECALL THE DEFENDANT, JULIUS ROSENBERG, TESTIFIED  
THAT OUR AMERICAN SYSTEM OF JUSTICE WAS BETTER WITH HIS APPROVAL AND WAS  
PREFERRED OVER RUSSIAN JUSTICE. EVEN THE DEFENDANTS REALIZED BY THIS  
ADMISSION--THAT THIS TYPE OF TRIAL WOULD NOT HAVE BEEN APPROVED THEM  
IN RUSSIA. CERTAINLY TO A RUSSIAN NATIONAL APPROVED OF CONSPIRACY TO  
DESTROY RUSSIA, NOT ONE DAY WOULD HAVE BEEN CONSIDERED IN A TRIAL, YET,  
THEY MADE A CHOICE OF DEVOTING THEMSELVES TO THE RUSSIAN IDEOLOGY OF  
NO GOD INSTEAD OF SERVING THE CAUSE OF LIBERTY AND FREEDOM. YOUR CRIME  
IS WORSE THAN MURDER."
