3. SUBJECT INFORMED [REDACTED] THAT HE WANTED TO DISCUSS INFO HE HAD CONCERNING MILITARY OFFICER'S INVOLVEMENT IN DEATH SQUAD ACTIVITIES. SUBJECT CLAIMS FIRSTHAND KNOWLEDGE OF PAST DEATH SQUAD OPERATIONS THROUGH HIS CONTACTS WITH MILITARY OFFICERS THAT HE TREATED WHILE ON ACTIVE DUTY. HE ALSO ALLEGES THAT HE WAS ORDERED TO STANDBY ON SEVERAL OCCASIONS AS MEDICAL OFFICER FOR DEATH SQUAD HIT TEAMS WHILE OPERATIONS WERE BEING CONDUCTED. SUBJECT TOLD [REDACTED] THAT HE STILL MAINTAINS CLOSE, PERSONAL CONTACT THROUGH HIS MEDICAL PRACTICE WITH MANY OF THE MILITARY OFFICERS

THAT HE PREVIOUSLY TREATED. THE LIST OF CONTACTS INCLUDES ALL OF THE RANKING AND MANY OF THE JUNIOR OFFICERS IN THE ARMED FORCES. IN ADDITION, SUBJECT SIAD THAT IN THE PAST HE HAD TREATED CAPTAIN EDUARDO ((AVILA)), MEMBERS OF THE AVILA FAMILY, HANS((CHRIST)) AND HIS FAMILY MEMBERS, AS WELL AS OTHER WEALTHY SALVADORANS.

4. OF MOST RECENT INTEREST IS SUBJECT'S INFO ON COL. ROBERTO ((SANTIVANEZ)) ALVAREZ [REDACTED] SUBJECT TOLD [REDACTED] THAT [REDACTED] OFFICER THAT SANTIVANEZ WAS FORMER HEAD OF ANESAL (SALVADORAN INTELLIGENCE AGENCY) AND THAT ROBERTO ((D'ABUSSION)) WAS HIS EXECUTIVE OFFICER. AFTER THE COUP IN 1979, SANTIVANEZ AND D'ABUSSION STOLE ANESAL FILES FOR USE IN ORGANIZING D'ABUSSION'S ANTI-SUBERSIVE CAMPAIGN. THEY LATER RECRUITED LT. ((LOPEZ)) SIBRIAN AND CAPTAIN ALVARO ((SARAVIA)) TO CARRY OUT DEATH SQUAD OPERATIONS. A PAYMENT PLAN (LATER DUBBED "PLANILLA") WAS DEVELOPED AT THIS TIME, WHEREBY OFFICER WOULD KEEP TRACK OF THE SUBERSIVES KILLED DURING THE MONTH AND D'ABUSSION WOULD PAY, BY THE HEAD, ACCORDING TO THE FOLLOWING SCHEDULE: CAMPESINO- \$5000.00 COLONES; PROFESSOR- \$10-15,000.00 COLONES; PRIEST - \$25,000.00 COLONES. ACCORDING TO SUBJECT, SANTIVANEZ WAS ALSO CONNECTED TO THE INDIVIDUALS INVOLVED IN THE SLAYING OF MONSEÑOR ((ROMERO)). FOLLOWING THE KILLING OF ROMERO, SANTIVANEZ WAS ALLEGEDLY GIVEN THE .22 HORNET RIFLE USED IN THE MURDER FOR DISPOSAL.

5. SUBJECT REPORTS THAT SANTIVANEZ WAS APPOINTED AS SALVADORAN CONSUL IN NEW ORLEANS IN NOVEMBER 1983 AND THAT IS FAMILY BACKGROUND IS PANAMANIAN, ALTHOUGH HE AND HIS WIFE ARE BOTH SALVADORAN.

6. SUBJECT REPORTED DETAILED INFO TO [REDACTED] RE THE SHERATON MURDER CASE. THERE WERE NO NEW FACTS REVEALED, ALTHOUGH SUBJECT CLAIMS THAT AVILA TOLD HIM PERSONALLY THAT HE HAD PLANNED AND ORGANIZED THE MURDER. IT IS APPARENT, HOWEVER, THAT SUBJECT WAS IN POSITION TO GATHER VERY SENSITIVE FACTS ABOUT THIS CASE AS HIS INTO TRACKS WITH WHAT STATION ALREADY KNOWS.

7. IN ADDITION TO ABOVE, SUBJECT REPORTED SKETCHY INFO ABOUT AIR FORCE CAPTAIN ROBERTO ((LEIVA)), ALLEGEDLY THE MOST ACTIVE AND MOST DANGEROUS MILITARY OFFICER INVOLVED IN DEATH SQUAD ACTIVITY. SUBJECT SAID THAT LEIVA ALSO FLIES INDIVIDUALS ILLEGALLY INTO THE U.S. USING PLANES OWNED BY GUILLERMO ((SOL)) BANG AND OTHER WEALTHY SALVADORANS. SUBJECT ALSO REPORTED THAT A LT. COL. ((MAJANO)) OF THE HACIENDA POLICE WAS IN CHARGE OF TERRORIST TYPE ACTIVITIES HANDLED BY THAT SERVICE. HE SAID THAT MAJANO HAD RECENTLY RETURNED FROM OVERSEAS ASSIGNMENT TO PARAGUAY. ADDITIONALLY, SUBJECT IDENTIFIED DR. (MAJOR) LISANDRO ((VASQUEZ)) SOSA AS OTHER DOCTOR OFTEN CALLED UPON TO STANDBY FOR MEDICAL

8. [REDACTED] DESCRIBED SUBJECT AS BEING TOALLY COOPERATIVE AND WILL ING TO ANSWER QUESTIONS ON ANY SUBJECT. ACCORDING TO [REDACTED] *OFFICER*  
SUBJECT HAS ALMOST PHOTOGRAPHIC RECALL AND CITIES DATES, NAMES AND PLACES OF EVENTS THAT HAPPENED SEVERAL YEARS AGO. SUBJECT SEEMS MOTIVATED BY A DESIRE TO END POLITICAL VIOLENCE IN EL SALVADOR, ALTHOUGH HE MENTIONED TO [REDACTED] THAT HE WAS HAVING FINANCIAL DIFFICULTIES BECAUSE OF THE TOUGH ECONOMIC TIME.
