1. AT 8500 HOURS LOCAL 27 OCTOBER SECUL RADIO ANNOUNCED THE IMPOSITION OF PARTIAL MARTIAL CAW THROUGHOUT KOREA, EXCEPT FOR CHEJU, WITH ARMY CHIEF OF STAFF CHANG SUNG HWA APPOINTED AS HARTIAL LAW ADMINISTRATOR. UNDER ARTICLE 48 OF CONSTITUTION PRIME MINISTER CHOE KYU HA HAS BEEN DESIGNATED AS ACTING PRESIDENT TOUR TO THE INCOPACITATION OF PRESIDENT PAK THROUGH AN ACCIDENT.

2. ANNOUNCEMENT EXTENDED WATION WIDE CURFEN, EXCEPT FOR CHEJU DO. FROM 8488 TO 2288 HOURS. ALL SCHOOLS IN KOREA HAVE BEEN DROCKED CLOSED INDEFINITELY.

3. ROK ARMY CAPITAL SECURITY COMMAND TROOPS AND TANKS TOOK UP POSITIONS IN SCOUL AT 0400 27 OCTOBER. ROK 20TH DIVISION HAS BEEN RELEASED BY THE COMBINED FORCES COMMAND AND RETURNED TO ROK UPCON. THIS DIVISION IS BEING POSITIONED AT THE KOREAN MILITARY ACADEMY EAST OF SEOUL, AS A RESERVE UNIT TO ASSIST IN MAINTAINING

SECURITY IN THE CITY.

4. AS OF 8545 27 OCTOBER, THE SECUL AREA WAS QUIET WITH THE CITY GRADUALLY AWAKENING. THERE ARE NO CURRENT INDICATIONS OF ANY

INCIDENTS OR POPULAR RESISTANCE TO DEVELOPMENTS.

THE CABINET SUPPORTS

ACTING PRESIDENT CHOE AND THE ROK MILITARY SUPPORT THE CABINET.
