1. NEW ODACID COURIER SCHEDULE PROVIDES ONE POUCH WEEKLY FROM LINCOLN DIRECT TO FIELD. REQUIRE TWO DIRECT OUTGOING AND INCOMING COURIERS WEEKLY.

2. RECENT COURIER SCHEDULE CHANGE ONLY ADDED ADDITIONAL SERVICE FOR WEST INDIES. DID NOT INCREASE EFFICIENCY OR FREQUENCY SERVICE MIAMI TO CENTRAL AMERICA. TWICE WEEKLY SERVICE FROM FIELD TO LINCOLN POSSIBLE ONLY IF MIAMI TO PANAMA (VIA CENTRAL AMERICA) COURIER WILL ACCEPT POUCHES FOR LARCO AND PANAMA ODACID WILL SEND OUT MONDAY VIA WEST INDIES COURIER POUCHES RECEIVED PANAMA SATURDAY.

3. PENDING ESTABLISHMENT TWO DIRECT COURIERS:

A. INSTRUCT ODACID PLACE LARCO MAIL IN SEPARATE POUCH ADDRESSED DIRECT NOT SEND TO MEXICO FOR RE-POUCHING (THIS TO ELIMINATE CONDITION CITED GUAT 199).
