AGREEMENT HAS BEEN REACHED WITH THE SOVIETS FOR INDIA TO ORDER TWELVE AN-12 TRANSPORTS AND TWENTY MI-4 HELICOPTERS. THE TOTAL COST OF THESE AIRCRAFT WILL BE RUPEES 20 CRORES [REDACTED] COMMENT: ABOUT FORTY MILLION DOLLARS U.S.). OF THIS COST, 18 CRORES WILL BE USED FOR PURCHASE OF THE AIRCRAFT AND 2 CRORES WILL BE USED FOR SPARE PARTS AND EXPENSES OF SOVIET TECHNICIANS WHO WILL ASSIST IN MAINTENANCE OF THE AIRCRAFT.
