GUATEMALAN ARMY ONCE HE HAD OUTLIVED HIS USEFULNESS. AS AN
UNEDUCATED PEASANT, [REDACTED], BAMACA WOULD HAVE HAD LITTLE TO
OFFER OTHER THAN WHAT HE COULD HAVE PRODUCED IN HIS INITIAL
DEBRIEFINGS. BAMACA'S HIGH-LEVEL POSITION IN ORPA WAS NOT
DISCOVERED UNTIL LONG AFTER HIS DEATH. [REDACTED]
EXPLAINED THAT IF BAMACA WERE STILL ALIVE IT WOULD ONLY BE BECAUSE
HE HAD COOPERATED FULLY WITH MILITARY INTELLIGENCE, WHICH WOULD
HAVE PRODUCED HIM ONCE THE JENNIFER ((HARBURY)) INVOLVEMENT MADE
THE CASE A "CAUSE CELEBRE."
