1. Reference is made to your memorandum dated 25 January 1954 and to memorandum to the Chief, WH from the Chief, SSD dated 16 February 1954.

2. Attached find reports covering information received from a reliable informant in New York.

3. A check of Security indices reveals no record on all names listed with the exception of S. Bolanos. On this name, the following was recorded:

COMMUNIST PARTY CONGRESS-Names of 10 Latin Americans are included in the list published in PRAVDA of the delegates attending the 19th Communist Party Congress. The Latin American delegates are R. Arizmendi, Uruguay; S. Bolanos Venezuela; D. Encina, and Mr. Terrazas, Mexico; L. Vergara, Chile. The Brazilian Communist Party sent two representatives however, their names were not published.

4. We will maintain contact with this informant and you will be kept advised of developments.
