3. Who normally gave [redacted] his assignments?
4. What was the normal process for review of [redacted] work?
5. Who decided whether [redacted] work was acceptable [redacted]
6. How far through the "targeting" process did the [redacted] target nomination packages [redacted] make it? What processes were followed in preparing those packages?
7. Did [redacted] convey to [redacted] any uncertainty with regard to the location of the FDSP target?
8. What instructions did [redacted] give to [redacted] with regard to any location uncertainty?
9. Did the OIG interview [redacted] If so, please provide the Board with a transcript.
10. Does the IG have a copy of [redacted] 15 April e-mail inviting people from various components to the 16 April meeting to discuss the FDSP target nomination package? If so, please provide the Board with a copy.
11. What explanation does [redacted] have for not raising his concerns regarding the location of the FDSP target with D/ADCI/MS [redacted]
12. Why did [redacted] on 7 May 1999, the day of the bombing, not inform his supervisor [redacted] D/ADCI/MS [redacted] or ADCI/MS Rod Isler of his conversation with [redacted] that we might have targeted the wrong building?
13. Was the need for overt targeting procedures writ large ever brought to the attention of D/OTI Jami Miscik? If so, what actions did she take or direct to be taken?
