Dear FOIA/PA Coordinator:

Please accept this correspondence as an "FOIA/PA REQUEST" which is authorized by Federal Statutes, 5 U.S.C. 552, and also 5 U.S.C. 532 a'.

also, I'd like to inform you at this time, that my reason for requesting any information/documents, is because I am going to be writing a "Book" and several Newspaper + Magazine articles, and a "chapter" of my "Book" will be dedicated to the "Central Intelligence Agency" and the rest of my "Book" will be pertaining to the "United States Justice Department."

at this point, I'd also like you to know that I am very aware of your Agency's policy/procedures in regards to the "FOIA and PA" — I do realize that I must pay your agency's "hourly wage" in your conduct a "records/documents search," and I am

also aware that I must pay for all copying of documents which I do request. So therefore, I am now giving you my permission to bill/charge me up to \$200.00 to fulfill my "FOIA/PA REQUEST."

What I am requesting is all non-classified reports which you have from September 11, 2001 concerning the "Terrorists Commercial Airline Jet attacks on both the "World Trade Center Towers" as well as the "Pentagon Building" as well as the "Jet-crash into the vacant-field" in the State of Pennsylvania on September 11, 2001. I am requesting non-classified "pre-9/11/01" intelligence information which your agency, and any Foreign Government's agencies provided to you as to any warnings/alerts that "jets" could be used to crash into United States Buildings, and also any Foreign Government Countries Buildings? I would like all investigative and also intelligence reports which your agency was responsible for writing, or received

from other U.S. or Foreign Govern-
ments after the "jets crashed" into
all four crash sites? I would also
like any "eye-witness" reports, as
well as "victims-reports" which were
written from "9-11-01-TO-PRESENT." I
would like a list of all victims
who were in all three buildings
crash-sites that did survive, and
also those of firemen + policemen
that survived on the ground while
they were assisting victims of the
crashes? I would like the names
and addresses of all the 2,800 victims
who died on 9-11-01 and thereafter.
I'd also like a list of all victims
who were "alive" at all crash-sites and
transferred to hospitals? I'd also
like a list of all victims who died
at hospitals? I would like fifteen
(15) photocopied photographs of
all four crash-sites. also I
would like any and all confidential
CIA or FBI Informants who
provided information as to those
were going to be Terrorists, who
were fair to

planes/jets from U.S. pilots and crash them into buildings as bombs. I do realize from what I've been told, that the CIA + FBI did have some information from several sources that terrorist may take kidnapped jets and crash them into U.S. Buildings, but that nobody knew where the terrorist would crash the jets. I'd also like the "statements" made by the "San Diego FBI Informant" who lived in San Diego with several terrorist? I'd also like to request the statements which the "Minnesota Female FBI officer" gave to the FBI in Washington, as well as the statements which she gave to the CIA, that she had tried to relay "terrorists type information" to her superiors, but nothing was done, and the information she gave fell through the "system cracks" more or less? Also, I would like copies of all "warnings, alerts, and reports" that the CIA gave to the "Homeland Security Director, Mr. Tom Ridge", which

"documents/reports that your office
"has on 9/11/01 I would like a
"copy of no matter what the date
"of the documents/reports. Also, I
"would like all "investigative and
"intelligence reports/incidents" of
"after 9-11-01" which had to do
"with "terroristic-threats" which
"were made by terrorists to be
"made to any Federal or state law
"enforcement agency in the U.S., or
"their threats being intercepted
"via communications/informants?
"I would like copies of any
"final 9/11/01 Reports which the CIA
"or FBI submitted to the "9/11
"Independent Counsel Commission"
"and or any other "Congress or U.S.
"Senate Committee on Intelligence"?
"I'd like to see that N - 1"

attempting to obtain any "Classified or Secretative type" of information from your Agency. I would never request any type of information, or release any information which would risk any U.S. Government Investigation, and nor would I for one second consider risking Americans lives in any way - I'm 100% American and I have no use for any person who's a Terrorist, so please don't take why I'm requesting all the information that I am out of context. I wish to write a book to reveal the truth of the "9-11-01 attacks" and so hopefully we as Americans will never be attacked again as we were on 9-11-01.
