Any and all documents, photographs, records and correspondence referencing Arne Treholt and dealing with events between the period of Feb. 1, 1979 through Aug. 25, 1982.

Mr. Treholt has signed a privacy waiver, a copy of which is attached.

For your information, but not as a limiting factor in this request, Mr. Treholt is a former Norwegian diplomat serving with the Norwegian U.N. delegation during the aforementioned period. For your information, but not as a limiting factor in this request, Mr. Treholt was under investigation for espionage on behalf of the Soviet Union.

If this request is denied in whole or part, I ask that you justify all deletions by reference to specific exemptions of the FOIA for each withheld document. I expect you to release all segregable portions of otherwise exempt material.

The records requested are sought as part of newsgathering and not primarily for commercial use. The requester is a freelance journalist working for Fenris Film, an Oslo-based documentary producer.

I am willing to pay fees up to \$100 for duplication and other services without the need for further confirmation. Please consult me if fees will exceed \$100 and I will authorize an additional payment.

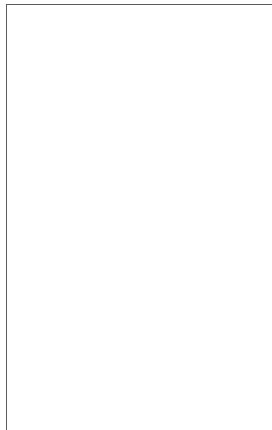
