You suggested that I "refine the scope of [my FOIA] request" with a time frame and more specific description of information. Accordingly, the specific records sought are:

1. All records of Five Star Trust and U.S. Mortgage and Trust Company related to their use for LAUNDERING MONEY from funds generated by the CIA, DoD, DEA, NSA, or other government agencies or private organizations, from 1985 to present.

2. All records regarding any INQUIRIES about the above matter.

3. The precipitating event for the creation of records is:

The INVOLVEMENT of the above agencies, both individually and collectively, in drug trafficking and laundering money by and through accounts in foreign-based banks under two "Trusts" names FIVE STAR TRUST and UNITED STATES MORTGAGE AND TRUST COMPANY. (Five Star Trust is an Isle of Man Trust, assigned IRS Taxpayer Identification Number: 61-6234232).

4. The time period for which records are believed to have been created or compiled are:

> From 1962 to 1975 from operations in the Golden Triangle of Southeast Asia; from 1970 to 1991 in Cental America; and from 1980 to present in Columbia and other South American countries.

5. This request includes all records related to the attempted laundering of CIA and DoD drug trafficking funds via:

> A Japanese CD issued by the MITSUI BANK LTD., Home Office in Tokyo, Japan in the 1970 to 1980 time period, in the amount of 318 billion Japanese Yen (CD #4051100-92),

## REQUEST FOR EXPEDITED PROCESSING

Dear Mr. Pealock:

This is a final response to your 21 June 2009 Freedom of Information Act (FOIA) request received in the office of Information and Privacy Coordinator on 1 July 2009, for records on:

1. Five Star Trust

2. U.S. Mortgage and Trust Co.

Your FOIA request cannot be accepted in its current form, because it would require the Agency to perform an unreasonably burdensome search. The FOIA requires requesters to "reasonably describe" the information they seek so that professional employees familiar with the subject matter can locate responsive information with a reasonable amount of effort.
