TERMINATED, AND DTLINEN NOW OPERATING ON SOUND BASIS WITHOUT UNDUE RISK CO-
 WORKERS OR GERMANS IN EAST. RECENT DEVELOPMENTS FORCE CONCLUSION THAT DESPITE
INTENSIVE EFFORTS MADE PAST SEVERAL YEARS PLACE DTLINEN ON SOUND SECURE OPERA-
TIONAL FOOTING, IT IMPOSSIBLE RUN CLANDESTINE EASTERN CPS WITH REQUISITE
SECURITY PROFESSIONALISM FROM DTLINEN FRAMEWORK WITHOUT CONSIDERABLE AND
PROBABLE CLEARLY UNDUE RISK EASTERN CO-WORKERS AT LEAST SO LONG AS FEDREP AND
WEST BRLN GOVTS UNWILLING OR UNABLE AFFORT TO GROUP CONSIDERABLY GREATER
MEASURE SUPPORT, PROTECTION, COOPERATION THAN THEY OBVIOUSLY PRESENTLY WILLING
 DO OR LIKELY BE WILLING DO IN PREDICTABLE FUTURE. RECENT DEVELOPMENTS SERIOUSLY

SINCE IF MFS CONVINCED THEY HAVE SUCCEEDED COMPLETE DESTRUCTION OF GROUP THEY WILL WITH LITTLE QUESTION SHIFT CONCENTRATED ATTACK BRUNT OF WHICH PREVIOUSLY BORNE BY DTLINEN TO OTHER GROUPS.

2. HOWEVER, BELIEVE FURTHER INSISTENCE MAINTAIN DTLINEN SUBSTANTIALLY PRESENT FORM NO LONGER FEASIBLE AND IN FACT LIKELY ON LONG RUN CAUSE GREATER LOSSES OUR POSITION VIS-A-VIS OTHER ASPECTS KUCAGE EFFORT THAN JUSTIFIED. BELIEVE CAN NO LONGER JUSTIFY TO BRLN SENAT, TO CAWASH OR UTILITY RETENTION ABTEILUNG-7 IN PRESENT FORM. SUCH SOURCES AS MAY JUSTIFY WILL CONSIDER TURNING OVER AT PROPER TIME TO DIRECT BOB C/O HANDLING. AWARE POSSIBILITY MAY NOT BE ABLE TO TRANSFER SOME SOURCES THIS FASHION IN WHICH CASE MAY HAVE TO BE SATISFIED WITH PLACING THEM ON ICE AT LEAST TEMPORARILY WITH APPROPRIATE ARRANGEMENTS FOR REVIVAL. PROPOSE CONVEY THIS TO LIPSCHITZ AND BRANDT IN NEAR FUTURE AND BELIEVE SHOULD BE FOLLOWED BY SIMILAR ADVICE TO CAFALCATE ET AL AND SPECIFICALLY UTILITY. IN ACCORDANCE ABOVE AND SUGGESTIONS REF A WILL ATTEMPT CONVINCING BRLN SENAT RELEASE OFFICIAL STATEMENT INCLUDING AS MUCH OF ABOVE AS STILL CONSISTENT SITUATION AND APPROPRIATE SPECIFICALLY POINTING OUT DTLINEN IS SUBJECT INTENSIVE CAMPAIGN BY MFS DESTROY KIT, INTENSITY OF WHICH HAS REACHED POINT WHERE IN ORDER AVOID RISK DDR RESIDENTS DTLINEN HAS DECIDED UNDERTAKE NO MORE OPERATIONS INTO SOVZONE WHICH MIGHT THEREBY EXPOSE GERMANS TO MFS PERSECUTION BUT THAT OTHER PUBLIC CHARITABLE ETC, ACTIVITIES OF ORGANIZATION TO CONTINUE. UNWILLING ISSUE SUCH STATEMENT PROPOSE NEWHAM ISSUE HIS OWN STATEMENT WITH IF POSSIBLE PRIOR AGREEMENT SENAT AND CAWASH THEY WILL SUPPORT OBJECTIVELY IF QUESTIONED.

4. AS SECOND POINT DESIRE PROPOSE BOTH BRLN AND FEDREP LEVEL THAT IN ORDER AVOID GIVING MFS EASY PUBLIC VICTORY INSPIRING EAST TO INTENSIFY ATTACKS OTHER GROUPS AND BY CONCESSION SERIOUSLY DAMAGE TOTAL COLD WAR EFFORT AND TO SOME EXTENT MORALE DDR POPULACE WE CONTINUE EASTERN PROPAGANDA AND WELFARE ACTIVITIES DTLINEIN INCLUDING BALLOONING WITHOUT CHANGE OF NAME.

5. WITH REGARD NEWHAM DESIRE PROPOSE THAT IN VIEW MANIFEST UNFAIRNESS HE NOT BE REMOVED UNTIL OUTCOME CURRENT TRIALS, INVESTIGATIONS AT WHICH TIME WE FULLY AND FRANKLY DISCUSS HIS CONTINUATION WITH DTLINEIN. AS MAXIMUM POSITION IF OUTCOME INVESTIGATIONS, TRIALS SATISFACTORY WE DESIRE PROPOSE RETENTION NEWHAM BUT IN CAPACITY NOT IN ANY CONNECTED CLANDESTINE OPS AND WITH HIM MADE RESPONSIVE TO APPROPRIATE GERMAN BEIRAT OR OTHER BODY ESTABLISHED TO INJECT ADDITIONAL ELEMENT OF RESPONSIBILITY AND ACCEPTANCE. IN ADDITION PROPOSING THIS LIPSCHITZ BRANDT/ [] LEVEL RECOMMEND AFTER FULL CONCESSION TO POLITICAL REQUIREMENTS EXPRESSED BY BONN NOT BYPASS [] ENTIRE PROBLEM SHOULD BE DISCUSSED WITH CAUSA BEFORE ACCEPTING ANY LESS POSITION THAN THIS.

IF THESE TACTICS FAIL BELIEVE WE MUST FACE NECESSITY REMOVING NEWHAM FROM LEADING POSITION DTLINEN ALTHOUGH NOTE THIS NOT LIKELY REMOVE HIM AS CONTROVERSIAL FIGURE GERMAN SCENE AND WILL FACE US WITH DISPOSAL PROBLEM SOME PROPORTIONS WHICH WE OBLIGATED MAKE CONSIDERABLE SATISFACTORILY SOLVE. BELIEVE NEWHAM (AND C. J.) AFTER MOST RECENT DISCUSSIONS WITH THEM RECONCILED THIS EVENTUALITY IF BECOMES ABSOLUTELY ESSENTIAL. NEWHAM HAS STATED HAS NO INTENTION LEAVING GERMANY OR WITHDRAWING FROM POLITICAL ARENA AND MAY DECIDE IF LEAVES DTLINEN MOVE TO FEDREP. CANNOT YET MAKE FIRM RECOMMENDATIONS DISPOSAL BUT BELIEVE WORKABLE SOLUTION PROBABLY POSSIBLE BY SUPPORTING HIM SET UP PUBLISHING FIRM PERMIT HIM CONTINUE SIMILAR ACTIVITIES ALTHOUGH NOT ON GROUP BASIS AS HE HAS TENTATIVELY PROPOSED AS POSSIBLE SOLUTION AS PREVIOUSLY REPORTED.

7. ON BALANCE EVEN IF FORCED THIS FAR AND RECOGNIZING DIFFICULTY SECURING NEW EFFECTIVE TITULAR HEAD DTLINEN STILL FEEL IT IMPORTANT RETAIN GROUP AS FORCEFUL RESISTANCE ORGANIZATION EVEN THOUGH SEPARATED COMPLETELY FROM CLANDESTINE OPS SINCE IT FILLS NEED NOT FILLED BY ANY OTHER KUCAGE ELEMENT.

8. CONSIDER IT IMPORTANT WE MOVE ON THIS PROBLEM FAIRLY RAPIDLY INCLUDING PROPER SURFACING AT CAUSA LEVEL IN ORDER AVOID POSITION BEING PREJUDICED BY FURTHER DISCLAIMERS FROM GERMANS OR POSSIBLE EFFORT SADDLE SOLE RESPONSIBILITY ON U.S. ETC. WOULD APPRECIATE YOUR VIEWS AND COMMENTS SOONEST. (END OF MESSAGE)
