1. WHILE RECOGNIZING WINTERSTEIN'S SENSITIVITY RE HIS OWN MEMOIRS, YOU MAY WISH POINT OUT THAT COPY IN HANDS LARGE PRIVATE AMERICAN PUBLISHING ENTERPRISE WHICH CAN PUBLISH AS IT SEES FIT HAVING APPARENTLY OBTAINED LEGAL RIGHTS DO SO.
2. BELIEVE THAT DIPLOMATIC APPROACH VIA FEDREP INAPPROPRIATE, SINCE EVEN U.S. GOVERNMENT CANNOT GUARANTEE PREVENT PUBLICATION. NOTE FURTHER THAT IT APPEARS THERE MAY WELL BE ADDITIONAL COPIES OR EXTRACTS THESE MEMOIRS BEING PEDDLED EUROPE, SO THAT EVEN SUPPRESSION U.S. DOES NOT GUARANTEE THEIR NON-PUBLICATION., APART FROM UNFAVORABLE LIGHT CAST UPON FEDREP IF ATTEMPTS SUPPRESS BECAME KNOWN AS WOULD SEEM INEVITABLE.
