SUBJECT: POSSIBLE TERRORISM LEAD

ACTION REQUIRED: SEE PARA 3.

1. IDEN A CALLED C/SVMACE 24 APRIL 1986 REGARDING POSSIBLE TERRORISM LEAD. IN LATE MARCH 1986, IDEN A WAS CONTACTED BY IDEN B, STATING SHE WAS RESEARCHING A POSSIBLE BOOK ON TERRORISM AND HAD ESTABLISHED CONTACT WITH IDEN C. SHE PLANNED TO VISIT IDEN C IN THE NEAR FUTURE TO DISCUSS TERRORISM, AND ASKED IDEN A IF SHE COULD CALL HIM IF SHE PICKED UP ANYTHING OF SIGNIFICANT AND URGENT INTEREST TO NVBLAZON. IDEN A AGREED TO PASS ANY INFORMATION TO THE APPROPRIATE AUTHORITIES. IDEN B CALLED IDEN A 24 APRIL REQUESTING THAT SHE BE CONTACTED IN PARIS IMMEDIATELY AT IDEN D.

2. THERE ARE NO HEADQUARTERS TRACES ON IDEN B. COMMENTS BY IDEN A AND CONTACT INSTRUCTIONS ARE INCLUDED IN IDEN CABLE. HEADQUARTERS TRACES SENT TO [] IN OCTOBER 1985 (DIRECTOR 58942) ON IDEN C ARE ALSO INCLUDED.

3. C/SVMACE APPROVES [] DESIGNATE APPROPRIATE OFFICER TO CONTACT IDEN B AND OBTAIN THE URGENT INFO SHE HAS FOR PNREADY. REQUEST [] CONTACT IDEN B AT IDEN D TO DETERMINE IF SHE HAS ANY INFO OF VALUE. [] OFFICER SHOULD STATE THAT A MUTUAL FRIEND, WITH WHOM SHE HAD LUNCH AT THE INTERNATIONAL CLUB AT 1800 K ST, HAD ASKED TO LOOK HER UP IN PARIS.
