1. [] MET IDENTITY A (SUBJECT) AS PLANNED
ON 27 APRIL 1986. SUBJECT WILL LEAVE ON THE 0715 TGV FOR LAUSANNE,
SWITZERLAND, ON 30 APRIL TO INTERVIEW JWFISHY/2, WHO HAS CALLED
SUBJECT IN PARIS SEVERAL TIMES TO CONFIRM THE INTERVIEW SHE HAS
SOUGHT. SHE WILL MEET IDENTITY AT THE GRAND HOTEL AND PROBABLY
LUNCH THERE, TOO. SHE WILL RETURN TO PARIS LATE THE SAME DAY.

2. SUBJECT HAD NO URGENT INFORMATION TO CONVEY. HER CHIEF
REASON FOR WANTING CONTACT APPEARED TO BE A DESIRE TO GAIN AN
APPRECIATION OF WHAT MEETING A PERSON LIKE JWFISHY/2 MIGHT BE LIKE
IN TERMS OF HER PERSONAL SECURITY. AT ONE POINT, SHE ASKED IF IT
WOULD BE A GOOD IDEA TO HAVE A PNREADY OFFICER AT THE MEETING
SITE IN LAUSANNE TO ENSURE HER SAFETY. WE STATED WE THOUGHT THE
SECURITY SITUATION IN SWITZERLAND WAS GOOD, THAT JWFISHY/2 APPEARED
TO HAVE NO REASON TO THREATEN HER, AND THAT HER PLANS TO MEET OPEN-
LY IN PUBLIC WERE SOUND. WE SUGGESTED JWFISHY/2 MIGHT WANT TO USE
THE ENCOUNTER TO FURTHER HIS OWN ENDS AND THAT SUBJECT SHOULD THERE-
FORE BE ALERT. AT THE CONCLUSION OF OUR MEETING, WHICH INCLU-
DED LUNCH, SUBJECT EXPRESSED HER GRATITUDE FOR OUR COUNSEL AND
CLAIMED TO BE FAR MORE RELAXED ABOUT HER UPCOMING APPOINTMENT.

3. SUBJECT TURNED OVER HER FILE OF CLIPPINGS ON JWFISHY/2
FOR OUR PERUSAL, ADDING THAT SHE HAD ALSO DONE SO FOR IDENTITY
B WHO MADE PHOTOCOPIES.

4. WE LEVIED NO REQUIREMENTS ON SUBJECT, THOUGH SHE OFFERED
TO SERVICE ANY WE MIGHT HAVE. SHE VOLUNTEERED THAT AN IDENTITY C
OFFICER HAD ASKED HER TO POSE SOME QUESTIONS TO JWFISHY/2 AND
AFFIRMED THAT SHE HAD MADE SOME OTHER VERY GOOD CONTACTS WHILE IN
IDENTITY D.

5. SUBJECT GRATEFULLY ACCEPTED OUR OFFER TO CALL HER ON
1 MAY 1986 TO LEARN IF THE TRIP HAD GONE WELL. WHILE IT DOES NOT
SEEM SHE WILL HAVE MUCH OF INTELLIGENCE VALUE TO CONVEY, WE
SHALL USE THE OPPORTUNITY TO MEET AND GET A FIX ON JWFISHY/2.
