RADICAL ARAB CIRCLES. THE TROUBLE C ] HAD WITH JWFISHY/2  
CENTERED ON OUR INABILITY TO VERIFY THE AUTHENTICITY OF THE  
INFORMATION HE PROVIDED AND PIN DOWN DETAILS OF HIS CLAIMS.  
ALTHOUGH HQS FILES MAY BE ABLE TO PROVIDE MORE DETAILS, THERE  
ALSO SEEMS TO HAVE BEEN A PAST BUSINESS RELATIONSHIP BETWEEN  
C ] AND JWFISHY/2 AND PERHAPS A FALLING OUT BETWEEN THE  
TWO. ANY FURTHER INFO HQS CAN PROVIDE ON C ] AND JWFISHY/2  
WOULD BE APPRECIATED, PARTICULARLY ON THE VALIDITY OF THE  
INFORMATION EITHER INDIVIDUAL MAY HAVE PROVIDED.
