1. ACTION REQUESTED: RESPONSE.

2. SUBJECT HAS NOTIFIED US THAT, SOONER THAN EXPECTED, COURT PROCEEDINGS IN LYON AGAINST KLAUS ((BARBIE)) MAY START AS EARLY AS OCTOBER 1986. AS HE CONTINUES TO USE THE CASE AS A PRETEXT FOR HIS INQUIRIES AND POSSIBLE LEGAL ACTION AGAINST GENOUD AND POSSIBLY VERGES, HE IS PRESSING US FOR SOME HQS REACTION TO HIS PRESENTATIONS AND PROPOSALS. (TO BEST OF OUR KNOWLEDGE, THERE HAS BEEN NO HQS TRAFFIC RE THIS SITUATION SINCE REF AND NEW YORK MEETING WITH SUBJECT BY IDEN REF AND ( ) ON 4 JUN 86.)

3. SUBJECT HAS ALSO INQUIRED ABOUT LIST OF BOOKS ON INTERNATIONAL TERRORISM RECOMMENDED BY HQS FOR BACKGROUND READING. AS YOU RECALL, HE HAD ASKED ABOUT SUCH A LIST IN LAST TWO MEETINGS WITH HQS OFFICERS.

4. WE HAVE TENTATIVE DATE WITH SUBJECT FOR 21 JULY. SOME INDICATION OF CURRENT HQS POSITION AS WELL AS LIST OF RECOMMENDED BOOK TITLES SHOULD REACH US NLT 17 JULY. IT WOULD BE MOST HELPFUL FOR IDEN REF OR ANOTHER OFFICER FAMILIAR WITH SITUATION TO JOIN ( ) FOR NEXT MEETING WITH SUBJECT, WHICH COULD BE CHANGED FOR HQS OFFICER'S CONVENIENCE IF NECESSARY.
