1. SOURCE OF REF A INFO IS ANDRE ((BENAYER)). A JEWISH
BELGIAN/ISRAELI DUAL CITIZEN WHO MET WITH [] ON 26
JUNE 1987 PER INSTRUCTIONS FROM [] BENAYER IS THE
SUB-SOURCE OF REF C. HE CLAIMS A CLOSE ASSOCIATION WITH
FRANCOIS ((GENOUD)) DATING TO 1982. BENAYER STATED THAT GENOUD
NOW NEEDS HIM FOR HIS KNOWLEDGE OF ITALIAN/SICILIAN GEOGRAPHY,
ROADS, ETC.; A KNOWLEDGE STEMMING FROM THE TRANSPORTATION
NETWORK BENAYER HAS ESTABLISHED FOR HIS ADMITTED DRUG TRADE.
HE DID NOT STATE HOW MUCH, IF ANY, DETAIL HE HAS GIVEN TO
GENOUD. BENAYER ALLUDED, BUT NEVER DIRECTLY STATED, THAT
GENOUD'S INFO ORIGINATED FROM "GEORGI".

2. BENAYER PREVARICATED BEFORE PROVIDING THE NAME OF THE
POSSIBLE TERRORIST TARGET AND CHANGED REF C STATEMENT THAT MORE
THAN THE IRANIANS ARE INVOLVED. IT WAS ONLY HIS OPINION THAT
THE TERRORISTS MIGHT TRY TO DRIVE THE CAR ON BASE. BENAYER
STATED THAT HE DID NOT TRUST THE ISRAELIS (HE SPENT TEN YEARS
IN AN ISRAELI PRISON) AND THEREFORE WISHED TO SHARE HIS INFO
WITH U.S. AUTHORITIES.

3. BENAYER SAID THAT HE LAST SAW GENOUD ABOUT THREE, BUT
NOT MORE THAN FOUR, WEEKS AGO. HE DID NOT SPECULATE ON A
POSSIBLE DATE FOR THE ATTACK, BUT SAID THAT HE COULD BE IN
TOUCH AGAIN "THE MIDDLE OF NEXT WEEK." PRESUMABLY, THEN, HE
BELIEVES NOTHING WILL HAPPEN BEFORE 1 JULY.

4. [] WAS NOT IMPRESSED WITH BENAYER'S PRESENTATION
AND TREATS HIS INFO WITH SKEPTICISM, BUT BELIEVES THAT
ADDITIONAL DETAIL SHOULD BE DISSEMINATED AS FOLLOW-ON TO REF
C.
