2. [] MET WITH [] [] [] IN BERN
HOTEL ON 22 OCTOBER. AS OF THIS DATE, [] HAS NO INFORMATION
ON THE CARLOS ORGANIZATION DESTINATION. ACCORDING TO FRANCOIS
((GENOUD)) THE CARLOS DAMASCUS PHONE NUMBER WAS OUT OF ORDER CIRCA
16 SEPTEMBER SO GENOUD BELIEVES THE CARLOS GROUP MOVED IN MID-
SEPTEMBER. GENOUD EXPECTS TO HEAR FROM CARLOS WHEN THE GROUP IS
RESETTLED. GENOUD MENTIONED TO [] THAT THE FRENCH LAWYER
((VERGES)) VISITED CARLOS IN DAMASCUS 11-14 SEPTEMBER AND THE
CARLOS COURIER ((MAHMOUD)) VISITED GENOUD IN LAUSANNE DURING THE
SAME TIME FRAME.

3. INFORMATION CONTAINED IN AN EARLIER [] CALL FROM
[] INDICATED THAT CARLOS HAD RELOCATED TO LIBYA. THIS INFORMATION
IS SOURCED SOLELY TO FRENCH TV REPORT OF EARLY OCTOBER WHICH HEARD
BY GENOUD AND PASSED ON TO [] (NOT SUBSTANTIATED BY [] ACCESS).
[] IMPRESSION IS THAT CARLOS GROUP LEFT SYRIA AND DID NOT
RELOCATE TO ALI ((ISAWI)) HOME IN HOMS. [] NOTED THE LOGIC OF
THE GROUP'S TECHNICAL EQUIPMENT BEING STORED IN HOMS AND GROUP
WEAPONS BEING TRANSPORTED TO PPS SAFEHAVEN IN LEBANON. []
MENTIONED THAT IF CARLOS INDEED HAS GONE TO GROUND, THE GROUP CAN
BE FOUND BY A CAREFUL WATCH FOR JOHANNES ((WEINREICH)) VISITS TO
MERCEDES DEALERS AND CONTACTS IN GERMAN EX-PAT COMMUNITIES.
NOTE: GENOUD TRAVELLING TO ALGIERS IN LATE OCTOBER ON BUSINESS
NOT BELIEVED RELATED TO CARLOS MOVE. [] GOING TO NUERENBERG
ON 26 OCTOBER TO PICK UP SON FOR ONE WEEK SCHOOL VACATION.
