1. ACTION REQUIRED: NONE.

2. AT MEETING AT FRANCOIS ((GENOUD)) RESIDENCE IN DAMASCUS ON 10 DECEMBER, CARLOS COURIER ((MOHAMMAD)) SWORE TO SECRECY AND SPUDGINLY ADMITTED THAT CARLOS AND MAGDALENA ((KOPP)) ARE LIVING IN IRAQ. ((MOHAMMAD)) TOLD PNINFINITE DEBRIEFERS LATER ON 10 DECEMBER THAT ((MOHAMMAD)) WILL CONTINUE TO ATTEMPT CONFIRM WHEREABOUTS OF CARLOS ORGANIZATION MEMBERS. TO BEST OF ((MOHAMMAD)) KNOWLEDGE, GENOUD HAS NOT BEEN TOLD OF CARLOS' NEW SAFEHAVEN. ((MOHAMMAD)) CONSIDERS GENOUD LACK OF KNOWLEDGE UNLIKELY.

3. MOHAMMAD EXPLAINED THAT JOHANNES ((WEINRICH)) AND ALI ((ISSAWI)) TRAVELED FIRST BUT WERE REFUSED ENTRY TO LIBYA SO WENT ON "TO ANOTHER PLACE". CARLOS AND MAGDALENA ((KOPP)) TRAVELED BY AIR TO LIBYA TWICE BUT WERE REFUSED ENTRY AFTER ARRIVAL ON BOTH OCCASIONS. ((MOHAMMAD)) BELIEVES THE THREE TRIPS OCCURRED IN SEPTEMBER 1991. MOHAMMAD WAS MOST RELUCTANT TO REVEAL CARLOS LOCATION. ALTHOUGH ((MOHAMMAD)) CONSIDERS MOHAMMAD A FRIEND, ((MOHAMMAD)) ALSO KNOWS MOHAMMAD FOLLOWS CARLOS' INSTRUCTIONS VERY CAREFULLY SO IS CAPABLE OF STICKING TO COVER STORY OF CARLOS' WHEREABOUTS.

4. ((MOHAMMAD)) IS MAKING THIS JUDGEMENTAL CALL BY INSTINCT. ((MOHAMMAD)) FEELING IS THAT AT LEAST CARLOS AND MAGDALENA MAY STILL BE IN SYRIA BUT AT NEW RESIDENCE. ((MOHAMMAD)) BELIEVES THAT CARLOS WOULD GO ANYWHERE ELSE BUT LIBYA. IF CARLOS HAD CHOICE OF IRAQ, CARLOS WOULD NEVER APPROACH LIBYA OTHER THAN LAST RESORT. CARLOS CONSIDERS LIBYANS TO BE ANIMALS, LIFE IN LIBYA TO BE DEATH, AND CARLOS HAS ONGOING PERSONALITY FUED WITH SEVERAL HIGH-LEVEL LIBYAN OFFICIALS. ((MOHAMMAD)) BELIEVES CIRCUMSTANTIAL EVIDENCE POINTS TO CARLOS CONTINUED RESIDENCE IN SYRIA. MOHAMMAD MENTIONED THAT CARLOS IS FORBIDDEN BY "CARETAKERS" FROM TELEPHONING FROM SAFEHAVEN. MOHAMMAD IS NOW TRAVELING ON COURIER MISSIONS FROM BEIRUT RATHER THAN DAMASCUS -- WHICH, ACCORDING TO ((MOHAMMAD)), PROVIDES COVER FOR SYRIAN CONTINUED SPONSORSHIP. FINALLY, ((MOHAMMAD)) BELIEVES THAT MOHAMMAD HAS TIMELY AND FUNCTIONAL COMMUNICATION CHANNEL WITH CARLOS WHICH ALSO INDICATES TO ((MOHAMMAD)) THAT CARLOS REMAINS IN SYRIA. ((MOHAMMAD)) SUPPORTS REASONING BY STATING THAT MOHAMMAD ASKED GENOUD TO PROVIDE NEW 1992 CALENDAR/AGENDA INSERTS FOR BOTH CARLOS AND WEINRICH JOURNALS. ((MOHAMMAD)) BELIEVES THAT THIS REQUEST IS ANOTHER INDICATION THAT CARLOS' ORGANIZATION DISLOCATION IS MORE SMOKE SCREEN THAN RUDE REALITY.

5. ((MOHAMMAD)) STILL CONSIDERS CARLOS RELOCATION TEMPORARILY TO CUBA AS ALTERNATE POSSIBILITY. ((MOHAMMAD)) DID NOT RECOGNIZE THE VENEZUELAN LUBAN ((PESKO)) WHO ((MOHAMMAD)) BELIEVES COULD BE USED BY CASTRO AS MIDDLEMAN WITH CARLOS. ((MOHAMMAD)) MENTIONED THAT LATIN AMERICAN REVOLUTIONARY DOUGLAS ((BRAVO)) ATTEMPTED TO ARRANGE MEETING WITH
