2. We have not been permitted to contact any of the references mentioned in your memorandum. It is borne in mind that a majority of these are individuals of racial vectors and are wanted by the Greek police. Therefore the Director has to be careful to us in trying to find out their character.

- According to the French, the above was co-edited and proof-read by the Russian national socialist pro-German newspaper, "Journal du Travail", a propaganda and agitation paper for war purposes, the first edition of this paper dated on 1, June 1942.
