DEVELOPMENTAL PROJECT CANAKIN

1. To be used as a cut out and agent scout.
2. Will cover Slavic dissident groups including NES activity.
3. CANAKIN (ref: LGM-A-943).
4. (1) The French have originally requested CANAKIN's extradition to be tried on collaborationist charges in 1946. CANAKIN was at that time under our protection. In June 1948, CANAKIN was tried in absentia in Paris and sentenced to 20 years at hard labor. The above gives us practically complete control over CANAKIN's future life.
(2) CANAKIN was turned over for operational use by 5 2 to Andrew W. Stubbs in the fall of 1946. Direct contact has always been maintained.
5. (1) In contacting people CANAKIN usually represents himself as being employed by the "American Information Service".
(2) CANAKIN knows that for the past two and a half years he has been dealing with representatives of the AIS.

f. (1) Procurement of an Exit Permit.
(2) Same as above.

7. Since severing relations with us, CANAKIN has been mostly inactive and rather worried lest the French ever get hold of him. He occasionally submitted CE reports to his former associates LAMICK and CAHOGAN both of whom were employed by HUSTY. During his previous association with us CANAKIN was found to be a loyal and trusted agent.
