In compliance with your communication dated April 26, 1956 (Z.A. Inquiry no. 3022), recorded as Public Safety Inquiry no. 33 in which you requested the conduct of police record checks relative to the person of Subject, you are advised that the following details were extracted from available police records:

Personal data of Subject:

Neither are personal data of Subject's divorced wife available.

Personal data of Subject's parents:

Father: Franz GLASENAPP, born Feb 4, 1869 at Hohenreickendorf  
Mother: Maria GLASENAPP, nee VOSS, born Feb 16, 1862 at Kyritz.

Other notations in Berlin:

GLASENAPP was at the time issued the incriminating stamp in Steussdorfer Strasse showing the entries "A/IIb" and "Member of the NSDAP without holding office prior to May 1, 1937 and member of the SA). Measures on rehabilitation are not known.

Two penal notations on Subject are entered which in detail are cited under "Other notations" below. The first cited conviction is against the person of Subject.

Criminal Police notations:

On June 9, 1936 Subject was sentenced by the court in Berlin to three months imprisonment for favoritism.

On Feb. 19, 1954 he was sentenced to four months in prison by the court in Berlin on account of attempted fraud.

The following investigation procedures were instituted against him by the court in Berlin:

In 1950 for suspected fraud and on account of fraud and falsification of documents;

In 1951 on account of fraud;

In 1952 for suspected action as accessory after the fact and subversion of the law on protection of personal freedom;

In 1956 for suspected cheat.

For easy reference, please, find attached hereto a photostatic copy of the pertinent document maintained on this case by Berlin Criminal Police.

In addition, this office may draw your attention to the fact that, considering your note that Subject be residing at "12 Blumenthalstrasse Berlin W.35" local examinations were carried through in result of which it was established that GLASBEPP has never lived in said house.
