1. In supplement to reference A, the following information is submitted.
2. On 29 April 1955, ☐ met ~~Samuel DUBROVSKIY~~, Russian speaker at Radio Liberation and recent American citizen, at a meeting of the KFOR. DUBROVSKIY stated that a friend of his, Alexander ~~MURAVSKIY~~, wanted to submit some information to an American agency. ☐ agreed to see MURAVSKIY.
3. On 2 May 1955, MURAVSKIY appeared at the ☐ office and told ☐ that he was uneasy about his participation in subject association. He told ☐ the following about his involvement with subject.
  - a. Towards the end of November 1954, a friend of MURAVSKIY's, Boris ~~WOLF~~, of the Committee of United Vlasovites (KOV) of which MURAVSKIY is also a member, approached MURAVSKIY to join a new anti-Communist organization to be composed of both East and West Europeans. The new organization had the purpose of propagating anti-Communist propaganda and, most importantly, to carry out activities for intelligence services which these services could not do themselves because of cover problems. One example was the publishing of pamphlets and brochures. MURAVSKIY agreed to join.
  - b. Some days later WOLF appeared at MURAVSKIY's billets at Onalstein 2/II, ~~Wald/Indersfeld~~, with Friedrich Victor ~~WISSE~~. ~~WISSE~~ told MURAVSKIY that the new organization would be backed by influential circles in Bonn. He referred unclearly to the Blank office and to ~~WISSE~~ (Presumably Dr. Rudolph ASCHENAUER). MURAVSKIY was asked to sign (as the "Russian" representative) as

one of the founding members of the organization, to register the organization with the German authorities. MURAVSKIY agreed but asked WOLF why he did not himself sign as the "Russian" representative. WOLF made evasive answers. MURAVSKIY was asked to find other "clean people" from among the East European emigres to participate in the organization.

c. MURAVSKIY subsequently recruited his friend the Crimean Tatar Dmitriy ABDULOV (in the protocols of the association erroneously called Kheslav ABDULOV, a corruption of his first name) and (fnu) ABDULOV, a Serbian who is also living in Ludwigsfeld.

d. In later meetings with WOLF, WOLF told MURAVSKIY that RISSE is not the main force behind the organization, but the actual chief is a German who intends to remain behind the scenes for a year or two.

e. On 23 January 1955, RISSE and WOLF gathered the seven founding members (the minimum number necessary to register a society) in RISSE's billets at Wannich 22, Gowergasse 19/II. They were, in addition to RISSE:

- (1) Dmitriy ABDULOV, Chairman of the Crimean Tatar Anti-Bolshevik Association and member of the Central Bureau of ITSCHER.
- (2) Lothar OSIL, An Austrian, about 30 years old.
- (3) (fnu) ABDULOV, A Serbian and former intelligence man with General Brasov ABDULOV. Now working for CIC.
- (4) Alexander ABDULOV, Russian member of KOV and Deputy to WOLF in the Central Bureau of ITSCHER.
- (5) Erich ABDULOV. According to WOLF, a former German Intelligence Colonel in the latter stages of World War II on the staff of Marshal Ferdinand SCHONERER. Allegedly a friend of the deputy chief of the Bavarian LVF.
- (6) Vladimir ABDULOV, A Ukrainian who was brought in by OSIL. The meeting decided that the official foundation meeting would be held on 1 February 1955. RISSE insisted that the foundation meeting be held in a public restaurant to avoid creating the impression that the organization was clandestine. MURAVSKIY suspected at the time, because of WOLF's statements about there being a gray eminence in the background and because according to a German law there is no reason for an officially registered society to concern itself with meeting in a public place, that RISSE's insistence was due to the fact that he wanted to show the organization to someone else.

- f. On 1 February 1955, the members assembled at RISSE's billets and then proceeded to a small restaurant in the neighborhood. Board members, as listed in the protocols, were elected. RISSE paid for the meeting, the cost of which was around 80.00 DM. MURAVSKIY noticed another man in the restaurant sitting at a table near the entrance who left shortly after they came in. The man was around forty years old, short, somewhat corpulent and may have worn glasses.
- g. In mid-March MURAVSKIY noticed that KRULVIC had begun to shun him. When MURAVSKIY pressed KRULVIC for an explanation, KRULVIC told him that he had been warned by CIC not to become involved with the association, since the association was suspected of being some sort of Communist and/or SS effort. RISSE had been a Communist from 1928 to 1933. After 1945 he was elected to some official position as a Communist. KRULVIC wanted CIC to give him the task of observing the association but the CIC did not agree. KRULVIC then suggested that MURAVSKIY be an agent for the CIC in the association. CIC stated that MURAVSKIY was unacceptable because of his past collaboration with the SS. (MURAVSKIY is very upset at CIC's charge. He states he was a propaganda lieutenant for the ROA but had no connections with the SS. He added that he had given his complete biography to Bruno KAUSCHER in 1951, when the latter worked for a U.S. agency in Wink Kaserne, Munich.)
- h. MURAVSKIY states that the non-German members of the association do not know what is going on. RISSE and WOLF seem to be very active and there is much talk about intelligence activities. RISSE once showed MURAVSKIY an alleged Karlshorst plan for some two hundred Communist cover organizations in West Germany. He also told him the Soviets have infiltrated some five hundred good-looking women agents into West Germany. MURAVSKIY asked General Anton TURKUL about the association, but TURKUL told him WOLF had merely informed him he was participating without giving any details. SUCKOV once mentioned to MURAVSKIY that he (SUCKOV) had checked on RISSE with the Bavarian LfV and that he had been informed RISSE was "OK".
- i. At the last meeting in which MURAVSKIY participated on 6 April 1955, RISSE was very cool towards MURAVSKIY and mumbled something about getting rid of American agents. MURAVSKIY believes RISSE has found out about KRULVIC's CIC connection and what CIC told KRULVIC about the association. He believes there is either a leak in CIC, or ABDIKOV, who also knows the results of KRULVIC's check with the CIC, informed RISSE.
- j. MURAVSKIY and KRULVIC have drafted letters of resignation from the association. They have attempted to persuade ABDIKOV to also

resign but ANDREY suggested that they wait. ANDREY states that he informed him that the association would shortly receive money from the Blank office for the commencement of the association's work, and ANDREY stated that since he was the treasurer of the association the money would be turned over to him.

- b. MURAVYEV asked ☐ if advice as to what he should do. ☐ suggested that MURAVYEV stay in the organization to determine what it was really all about and in effect promised to cover MURAVYEV should his staying result in unfavorable consequences for him. ☐ has been instructed to tell MURAVYEV that he should take whatever course he (MURAVYEV) feels is in his best interest.
