The BFV, via Bonn USAFEUR Intelligence Division LO, states that the following individuals are ex-Gestapo members who it has reason to believe were recruited by East bloc intelligence services during the immediate postwar period when such persons were either arrested in countries like Poland or extradited upon request. Many falling into this category were given early releases, returned to the Federal Republic to serve as agents for the countries in which they had been interned.

DPOB: 17 April 1904 in Weimar
Residence: Bremen, Poelzigstrasse 1
Occupation: Formerly Kriminalrat; currently Dipl. Ing.

3. Bonn Base files contain no identifiable traces on Subjects.
