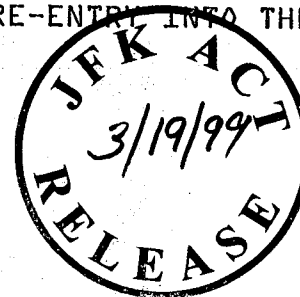

SUBJECT: BLACK PANTHER PARTY - CLEAVER FACTION; EXTREMIST MATTERS

1. A SENSITIVE SOURCE HAS REPORTED THAT FIVE BLACK PANTHER PARTY MEMBERS ARRIVED IN PARIS, FRANCE IN LATE MARCH 1973. THEY WERE PROVIDED LODGING AND TRAINING WHILE IN FRANCE BY THE CURIEL APPARATUS. THE GROUP IS NOW TRYING TO ARRANGE PLASTIC SURGERY AND FALSE DOCUMENTATION TO PERMIT THEIR CLANDESTINE RE-ENTRY INTO THE UNITED STATES.

WE WILL CONTINUE TO SEEK ADDITIONAL INFORMATION ABROAD ON THIS SUBJECT AND WILL ADVISE YOUR BUREAU OF ANY ADDITIONAL DETAILS AS THEY ARE AVAILABLE.

SUBJECT: BLACK PANTHER PARTY - CLEAVER FACTION; EXTREMIST MATTERS

1. A SENSITIVE SOURCE HAS REPORTED THAT FIVE BLACK PANTHER PARTY MEMBERS ARRIVED IN PARIS, FRANCE IN LATE MARCH 1973. THEY WERE PROVIDED LODGING AND TRAINING WHILE IN FRANCE BY THE CURIEL APPARATUS. THE GROUP IS NOW TRYING TO ARRANGE PLASTIC SURGERY AND FALSE DOCUMENTATION TO PERMIT THEIR CLANDESTINE RE-ENTRY INTO THE UNITED STATES. MEMBERS OF THIS GROUP ARE AS FOLLOWS:
