SUBJECT: 1. KORZHAN Michael, MUNICH 15, Mozartstrasse 11/III

2. BIHUS Yaroslava, MUNICH 15, Mozartstrasse 11/III, change of the entry in the registration card

I refer to the proxy by both the persons mentioned in the "subject", which has been submitted to the Prosecuting Authority MUNICH I, because I have submitted a self-accusation on behalf of the mentioned persons in order to, according to the law exempting from punishment, prevent punishment resulting from misrepresentation before the registration authorities.

I submit:

- Statement in lieu of oath of Elisabeth KORZHAN, née MOSKVA, at present at HAMMELBURG, drawn up before the notary Joseph DOTTER at HAMMELBURG on August 24,1954.
- Statement in lieu of oath of Michael KORZHAN in MUNICH 15, Mozartstrasse 11/III, drawn up in the office of the notary Dr.RIES in MUNICH on August 25,1954.
- 3. Statement in lieu of oath of Irene Yaroslava BIHUS in MU-NICH 15, Mozartstrasse 11/III, drawn up before the notary MITTENZWEI in MUNICH on August 12,1954.

It is clear from the above mentioned documents that the statements of Michael KORZHAN in the card-index of that office are wrong; he is married to Elisabeth KORZHAN, née MOSKVA, at present at HAMMELBURG, and not to Irene Yaroslava BIHUS.

The respective statements of Irene Yaroslava BIHUS, supposed to be KOR-

ZHAN, are wrong, too.

The submitted marriage certificate is a falsification, but, even if it should be correct, the marriage would be invalid because a second marriage is invalid if the first one continues to exist.

For those reasons I make, on behaf and by order of my mandators mentioned above, a

to change the card-index of the Registration Office and that of the proper police-station in the following way:

1. Michael KORZHAN in MUNICH 15, Mozartstrasse 11/III, is married

- to Elisabeth KORZHAN, nee MOSKVA, at present at HAMMELBURG.
- 2. The so-called Irene Yaroskava KORZHAN, née BIHUS, is single and her name is Irene Yaroslava BIHUS.

May I ask you for an early decision in writing; I refer to my telephone conversation with the chief of the Registration Office. My mandators intend to clarify the matter in the administrative way in case of a refusal.

Simultaneously I suggest that the the passports of my mandators should be changed properly; what has been said above is valid here, too. I ask you for a decision in writing.
