As requested in the reference, we advised Subject that he had been over- paid by \$400.00. We gave him a sterile copy of the attachment to the reference for his study and left him with the promise that the money which he had been allowed for travel from Munich to Paris and return would be subtracted from the sum which he owes us. We calculated the amount owed by him to be 1,596.00 DM, i.e., 3.99 DM per dollar. Subject at this first meeting pointed out that his expenses for the Munich-Paris round trip were 589.33 DM, which is somewhat more than we had allowed for the trip.</p> <p>2. At the second meeting Subject agreed to pay 1,006.67 DM, i.e., 1,596.00 minus 589.33 DM. We agreed to that and suggested that Subject pay a round figure of 1,000.00 DM. Subject agreed; however, he pointed out that, while the figures given him check out, he disagrees with the first figure in the listing. This figure is \$600.00 and represents the lump sum deposit to his holding account for the period from 1 July 1950 to 31 December 1952. Subject states that his understanding of the money paid into the holding account for this period was to be \$50.00 per month. Our records on this period of Subject's finances have been destroyed. Please check the record to see if Subject's claims are correct.
