- 2. (C) WE ARE SEEING THE FIRST NEGATIVE EFFECTS OF THE JANUARY 31 AP ARTICLE QUOTING OSI ON LITHUANIAN WAR CRIMES CASES (REPORTED REF A). MY STAFF RECEIVED AN EMOTIONAL CALL FROM LITHUANIAN PARLIAMENTARIAN EMANUELIS ZINGERIS FEBRUARY 2. BASED ON THE ARTICLE (NOW REPEATED WIDELY AND PROMINENTLY IN THE LITHUANIAN PRESS) AND THE MESSAGES OF CONDEMNATION ZINGERIS HAS RECEIVED CONCERNING THE ARTICLE'S CHARGES BY MEMBERS OF JEWISH COMMUNITIES IN THE UNITED STATES, HE IS SERIOUSLY CONTEMPLATING RESIGNATION FROM HIS

- 2. (C) ZINGERIS, A MAN OF MANY HATS -- CHAIRMAN OF THE HUMAN RIGHTS COMMITTEE, CHAIRMAN OF THE LITHUANIAN-AMERICAN PARLIAMENTARY CAUCUS, CHAIRMAN OF THE STATE JEWISH MUSEUM, DIRECTOR OF THE EUROPEAN INSTITUTE FOR DISPERSED ETHNIC MINORITIES, MEMBER OF THE EXECUTIVE BOARD OF THE RULING CONSERVATIVE PARTY AND CHAIRMAN OF THE PRESIDENTIAL HISTORICAL COMMISSION TO INVESTIGATE THE HOLOCAUST AND CRIMES COMMITTED UNDER SOVIET OCCUPATION -- IS THE ONLY JEW IN PARLIAMENT. GIVEN HIS STATURE, HE HAS BEEN ONE OF THE FEW FULLY EFFECTIVE INTERLOCUTORS ON WAR CRIMES ISSUES. ZINGERIS HAS COME UNDER FIRE BEFORE WHEN LITHUANIA HAS NOT MOVED AS ACTIVELY TO ADDRESS WAR CRIMES CASES AS IT SHOULD. NOW, HOWEVER, ZINGERIS FEELS PARTICULARLY UPSET THAT THE U.S. GOVERNMENT SHOULD TAKE SUCH A STRONG NEGATIVE POSITION AS REPORTED IN REF A.
- 4. (C) WE ARE WORKING CLOSELY WITH ZINGERIS -- AS WE ALWAYS DO -- AND ARE TRYING TO REASSURE HIM, BUT THIS INCIDENT ONLY CONFIRMS OUR BELIEF THAT THE RECORD NEEDS TO BE SET STRAIGHT AS SOON AS POSSIBLE. THEREFORE, UNLESS INSTRUCTED OTHERWISE, THE EMBASSY WILL USE THE FOLLOWING STATEMENT TO RESPOND TO ZINGERIS AND OTHER INTERESTED PARTIES:
- THE U.S. GOVERNMENT IS DISAPPOINTED THAT ACCUSED WAR CRIMINALS FROM THE NAZI ERA HAVE NOT STOOD TRIAL IN LITHUANIA. HOWEVER, NEITHER THE U.S. GOVERNMENT NOR THE U.S. EMBASSY ARE IN POSSESSION OF OR AWARE OF SPECIFIC EVIDENCE THAT THE RESULTS OF THE MEDICAL EXAMINATION OF FORMER VILNIUS SECURITY POLICE COMMANDER ALEKSANDRAS LILEIKIS ARE INACCURATE. FURTHERMORE, THE U.S. GOVERNMENT RECOGNIZES THAT LITHUANIA IS GOVERNED BY THE RULE OF LAW, AND THAT THE CASES OF LILEIKIS AND HIS FORMER DEPUTY, KAZYS GIMZAUSKAS, ARE MATTERS FOR THE COURT RATHER THAN FOR THE GOVERNMENT.
