NOTHING VERY EXCITING AT STAFF MEETING THIS MORNING. BURCH SAID THAT THE PRESIDENT'S PHOENIX APPEARANCE WAS A REAL SUCCESS ON ALL ACCOUNTS AND SPOKANE, WHILE IT WAS NONPOLITICAL, WENT WELL. TIMMONS SAID THAT THE MILITARY PROCUREMENT BILL AND SUPPLEMENTAL WOULD BE UP IN THE SENATE THIS WEEK AND HE WAS NOT OPTIMISTIC ABOUT THE OUTCOME. HAIG SAID THERE MAY BE A CABINET MEETING LATE IN THE WEEK ON THE "NEW INITIATIVES" WHICH WERE TO HAVE BEEN SUBMITTED BY EACH DEPARTMENT. HE WENT ON TO SAY THAT HEARINGS IN THE JUDICIARY COMMITTEE WOULD PROBABLY BEGIN LATE THIS WEEK, WITH CLOSED HEARINGS ALL NEXT WEEK AND OPEN TELEVISED HEARINGS BEGINNING TWO WEEKS FROM TODAY. HAIG CONCLUDED THAT THE PRESIDENT CAME OUT OF LAST WEEK ABOUT AS WELL AS COULD HAVE BEEN HOPED. IT WAS BAD, BUT THE WORST THEY HAD FEARED DID NOT HAPPEN. THEY HAD BEEN AFRAID THAT THE MATERIAL MIGHT BE VIEWED AS BEING SO REPUGNANT THAT A GROUND SWELL AGAINST THE PRESIDENT WOULD ARISE. THAT DID NOT HAPPEN.

THAT WOULD BE A DISASTER AND HE COULD NOT LET IT HAPPEN. HE SEEMED TO AGREE AND I GATHER HE WAS THINKING OF DIVIDING RESPONSIBILITIES BETWEEN BILL SIMON AND PERHAPS HERB STEIN, OR EVEN BRINGING IN A NEW ASSISTANT FOR ECONOMIC AFFAIRS. I POINTED OUT THAT THEY HAD ACTUALLY DESERVED MORE THAN THEY GOT IN VIEW OF THE PROPOSAL THEY HIT YOU WITH WHEN YOU ARRIVED. HE WAS NOT CONCERNED ABOUT THE LETTERS, JUST PASSING ON HOW THEY HAD BEEN RECEIVED.
