1. REference your TOHAK 153, I still do not understand who is unhappy. We held up taking action on the Peruvian wheat for 48 hours while Kubisch sought and obtained appropriate interagency clearances. As I remember it, I called Simon myself Friday night to get his clearance. Only after all of this did we go ahead with the cable informing the Peruvians of our decision. The coordination took place before the decision.
2. Against this background, I still do not know specifically who is unhappy and why. Can you provide me with more details?

TO: GENERAL SCOWCROFT

FROM: SECRETARY KISSINGER

1. REFERENCE YOUR TOMAK 153, I STILL DO NOT UNDERSTAND WHO IS UNHAPPY. WE HELD UP TAKING ACTION ON THE PERUVIAN WHEAT FOR 48 HOURS WHILE KUBISCH SOUGHT AND OBTAINED APPROPRIATE INTERAGENCY CLEARANCES. AS I REMEMBER IT, I CALLED SIMON MYSELF FRIDAY NIGHT TO GET HIS CLEARANCE. ONLY AFTER ALL OF THIS DID WE GO AHEAD WITH THE CABLE INFORMING THE PERUVIANS OF OUR DECISION. THE COORDINATION TOOK PLACE BEFORE THE DECISION.

2. AGAINST THIS BACKGROUND, I STILL DO NOT KNOW SPECIFICALLY WHO IS UNHAPPY AND WHY. CAN YOU PROVIDE ME WITH MORE DETAILS?
