I AM SCHEDULED TO MEET WITH AND GIVE A LUNCH FOR LUNS MONDAY AND I HAVE AN IMPORTANT MEETING WITH OHIRA IN THE AFTERNOON. ALSO, I HAVE TO PREPARE FOR THE TWO-DAY CENTO MEETING WHICH I CHAIR AND WHICH BEGINS TUESDAY MORNING.
- 2. PLEASE EXPLAIN MY SCHEDULING PROBLEMS TO HAIG AND SEE IF WE CAN'T RELIEVE THE PRESSURE TO GO TO FLORIDA.
- 3. I DON'T UNDERSTAND WHAT GOT ZIEGLER SO UPSET (TOHAK 214, PARAGRAPH 3). I PAID A PURELY PERSONAL CALL WITH NANCY ON THE PRIME MINISTER TO PAY OUR CONDOLENCES.
