I HAVE ASKED THAT REFTELS BE REPEATED TO YOU. THEY BRING TO YOUR ATTENTION A DEFAMATION SUIT WHICH BURCHETT HAS BROUGHT AGAINST TWO CONSERVATIVE AUSTRALIANS. ONE A LEGISLATOR. BURCHETT ALLEGES THAT FORMER SENATOR KANE AND DENIS WARNER HAVE SLANDERED HIM BY THEIR DESCRIPTION OF HIS ALLEGED PRO-COMMUNIST ACTIVITIES, PARTICULARLY DURING THE VIETNAM WAR.

2. AS PART OF HIS BRIEF BURCHETT HAS REFERRED TO A MEETING WITH YOU IN OCTOBER 1971 AS SUBSTANTIATING HIS BONA FIDES AS A NEUTRAL GOBETWEEN. EMBASSY CANBERRA HAS ASKED STATE FOR CONFIRMATION THAT A MEETING IN FACT TOOK PLACE AND ANY FURTHER GUIDANCE YOU WOULD CARE TO OFFER.

3. WE HAVE CONFIRMED THAT YOU DID MEET WITH BURCHETT AT THE REQUEST OF ROSS TERRILL AT A BREAKFAST HERE AT THE WHITE HOUSE ON OCTOBER 12, 1971. THERE WAS APPARENTLY NO MEMOON MADE. WIN LORD OR PETER RODMAN MAY RECALL MORE DETAILS.

4. IN THAT THE TRIAL MAY CONCLUDE OCTOBER 30, YOU MAY WISH TO CABLE GUIDANCE DIRECT TO CANBERRA. PLEASE ADVISE. 266
