  OR SIMPLY GENERALITIES? ENDERS WILL SEND A COMPLETE REPORT
  AS SOON AS HIS NEGOTIATIONS END.
  - 2. BILL SIMON CAME IN THIS MORNING BEFORE STAFF MEETING TO COMPLAIN MILDLY ABOUT NOT HAVING A COPY OF YOUR SPEECH. WHEN I POINTED OUT THE NATURE OF YOUR CONCERNS ABOUT HAVING THE SPEECH SCRUBBED IN THE ECOMOMIC BOARD MEETING, HE. TO MY SURPRISE, AGREED COMPLETELY. HE SAID HE DID NOT BELIEVE IN DOING BUSINESS BY COMMITTEE THAT WAY AND YOU WERE ABSOLUTELY RIGHT IN YOUR POSITION: HE EVEN SUGGESTED THAT I RAISE WITH THE PRESIDENT OUR CONCERN OVER THIS PENCHANT FOR DOING BUSINESS BY COMMITTEE.
