THERE FOLLOWS THE TEXT OF THE SOVIET NOTE DOBRYNIN DELIVERED YESTERNAY.

BEGIN TEXTS

THE US SPECIAL SERVICES ARE ATTEMPTING NOW TO FAN UP A SPY-SCARE CAMPAIGN; USING FOR THIS PURPOSE THE ARREST ON JUNE 27. OF A PASKALYAN AND A DEDEYAN AND ALSO SPECULATIONS ON ALLEGED MONITORING OF AMERICAN PHONES FROM THE TERRITORY OF THE SOVIFT EMBASSY IN WASHINGTON, ONE CANNOT FAIL TO NOTICE THE UBVISHULY PROVOCATIVE CHARACTER OF THIS BALLYHOO STARTED BY THE FAI APPARENTLY NOT WITHOUT THE KNOWLEDGE OF THE HIGHER AUTHORITIES.

TAKING INTO ACCOUNT NUMEROUS STATEMENTS OF H. KISSINGER ON UNDESTRABILITY OF GIVING WIDE PUBLICITY TO THE FACTS WHICH COULD BE USED BY THE ENEMIES OF THE DEVELOPMENT OF THE SOVIET-AMERICAN RELATIONS, THE SOVIET SIDE, AS IS KNOWN, DID NOT PUBLICIZE THE EXPULSION FROM THE SOVIET UNION OF THE AMERICAN INTELLIGENCE AGENTS SHORER AND KELLY, WHO WERE CAUGHT REDWANDED: THE EXPOSURE OF BUGGING DEVICES IN THE PREMISES OF THE SOVIET OFFICES IN WASHINGTON AND IN SAN PRANCISCO: THE UNMASKING OF THE AMERICAN SPY KALININ.

OF AMERICAN TELEPHONES FROM THE TERRITORY OF THE SOVIET EMBASSY IN MASHINGTON THROUGH THE US GOVERNMENT IS WELL AWARE THAT THE ANTENNAS ON THE ROOF OF THE SOVIET EMBASSY IN MASHINGTON ARE USED FOR RADIO COMMUNICATION WITH MOSCOW AND WERE PLACED THERE ON THE BASIS OF RECIPROCITY.

UNDER THE CIRCUMSTANCES THE SOVIET SIDE MAY BE COMPELLED TO MAKE PUBLIC THE CASES OF OF SHORER, KELLY AND KALTNIN; THE DISCOVERY OF BUGGING TECHNIQUE IN THE SOVIET OFFICES IN THE UNITED STATES AND ALSO OTHER FACTS AT OUR DISPOSAL.

WE HOPE THAT THE US SIDE WILL SENSIBLY EVALUATE THE PRESENT SITUATION, ESPECIALLY WITH DUE ACCOUNT OF THE FACT THAT. THE BALLYHOU WHICH IS BEING FANNED UP NOW IN THE UNITED STATES CAN BE USED BY CERTAIN CIRCLES FOR DAMAGING THE CAUSE OF IMPROVEMENT OF THE RELATIONS BETWEEN OUR TWO COUNTRIES.
