TO THE WHITE HOUSE, EYES ONLY FOR DR. KISSINGER.

MET WITH PRESIDENT POMPIDOU AT NOON TODAY JUST AFTER ARMISTICE DAY CEREMONY. HE APPRECIATES VERY MUCH PRESIDENT NIXON'S INVITATION TO HAVE A MEETING AND IS RECEPTIVE TO IDEA. HE STATED FRENCH TERRITORY IN WESTERN HEMISPHERE OR US IMPOSSIBLE AS SITES FOR THIS MEETING. I STATED THAT IT WOULD BE IMPOSSIBLE FOR PRESIDENT NIXON TO HAVE MEETING IN FRANCE NOW. THEN I SUGGESTED IRELAND AS POSSIBLE SITE. HE WAS RECEPTIVE TO THAT LOCALE PROVIDING PRESIDENT WOULD NOT SITE. HE WAS RECEPTIVE TO THAT LOCALE PROVIDING PRESIDENT WOULD NOT HE WOULD BE DISTURBED BY PROTOCOL CALL ON PRESIDENT OF IRELAND. POMPIDOU SAID HE WILL MEET WITH BRANDT AROUND DECEMBER 3 OR 4, PRESIDENT ALSO EXPRESSED UNCERTAINTY AS TO PRESENT DIRECTION OF US POLICY. I REPLIED THAT IS BASIC REASON FOR SUGGESTED MEETING.

MY PERSONAL COMMENT AND RECOMMENDATION FOLLOW: LET ME KNOW AS SOON AS POSSIBLE WHETHER PRESIDENT NIXON WILL AGREE TO MEET PRESIDENT POMPIDOU IN IRELAND ANY TIME BETWEEN 10TH AND 14TH OF DECEMBER. I WRGE YOU TO DO EVERYTHING POSSIBLE TO HAVE OUR PRESIDENT ACCEPT THE ABOVE. I PERSONALLY FEEL THIS CAN BE A TURNING POINT FOR THE BETTER IN OUR RELATIONS WITH FRANCE AND EUROPE.
