1. IN JUNE TREASURY DEPT RECEIVED LENGTHY 477 CID REPORT OF 12 NOVEMBER 48 RE OFFSPRING-BANDERA GROUP WHICH ARRESTED AUGUST 48 WITH COUNTERFEIT FEDERAL RESERVE NOTES. OPERATION MENTIONED BRIEFLY. MGGG-112, SEPT 48; MGLA 1004 AND 2426. KNOWN CASE.
2. PER CID INVESTIGATION MARIA RYBZCUK STATED SHE COULD DETERMINE REAL SOURCE COUNTERFEIT 2500 DOLLARS. NO RESULTS OBTAINED BY CID. TREASURY NOW DESIRES PURSUE MATTER FURTHER THROUGH CID ESPECIALLY RE RYBZCUK AND MAXYM MOTECKO WHO GAVE FOUR AGENTS (MGGG-112) COUNTERFEIT MONEY, WHICH OFFSPRING ALLEGED CAME FROM UPA.
3. SINCE PERSONS INVOLVED NO LONGER EMPLOYED OFFSPRING, WE PLAN INFORM TREASURY GO AHEAD BUT WANT CLEAR WITH YOU. DO NOT INFORM OFFSPRING FURTHER ACTION CONTEMPLATED. CABLE YOUR COMMENTS AND PRESENT ADDRESS RYBZCUK IF KNOWN.
