<p>1. UPHILL'S OBSERVATION OF THE MERTEN COMPLEX AS OF EARLY DECEMBER PROVIDED THE FOLLOWING PICTURE /PRESUMABLY BASED PRIMARILY ON THE TELEPHONE COVERAGE OF MERTEN/.</p> <p>A. THE CONTACTS OF MERTEN TO HIS LAWYERS, POSSER AND HEINEMANN, ARE SURPRISINGLY FEW. HOWEVER, THEY ARE IN UPHILL'S OPINION NOT INSIGNIFICANT. MERTEN'S ACQUAINTANCE WITH BOTH IS CLOSE AND OLD.</p> <p>B. MERTEN'S CONTACTS WITH GREEK JOURNALISTS ARE ACTIVE, ABOVE ALL WITH MATHIOPOULOS /BONN CORRESPONDENT OF 'ELEPHTERIA'/ AND NIKOLOPOULOS /BERLIN CORRESPONDENT OF 'ATHENAIKI'/ . MERTEN DISCUSSES WITH MATHIOPOULOS ALL STEPS WHICH ARE INTENDED TO HAVE AN EFFECT UPON THE GREEK INTERNAL SITUATION.</p> <p>C. PARTLY THROUGH MATHIOPOULOS' INTERVENTION AND PARTLY DIRECTLY, MERTEN CAME INTO CONTACT WITH THE GREEK OPPOSITION AND WITH THE FORMER DEPUTY GRIGORIANIS /MEMBER OF THE EXECUTIVE COMMITTEE OF THE SOCIALIST PARTY/ AND WITH A REPRESENTATIVE /NAME UNKNOWN, ALLEGEDLY LOCATED IN FRANKFURT MAIN/ OF ANOTHER OPPOSITION GROUP. GRIGORIANIS WILL PROVIDE MERTEN WITH A GREEK LAWYER WHO WILL REPRESENT MERTEN IN HIS SUIT AGAINST MRS. MAKRI. THROUGH MATHIOPOULOS' ARRANGEMENTS, MERTEN IS IN CLANDESTINE CORRESPONDENCE WITH THE LAWYER APOSTOLOS APOSTOLIDES OF SALONIKA, LEONTUS-SOPHUS STREET 11 FOR THE PURPOSE OF EXCHANGING INCRIMINATING MATERIAL AGAINST MEMBERS OF THE GREEK GOVERNMENT. SOME OF THE CORRESPONDENCE IS SENT VIA AUGUST WIRTH OF SALZBURG.</p> <p>D. A CONTACT WAS ESTABLISHED BETWEEN MERTEN AND A REPRESENTATIVE OF THE ROYAL COURT /PSEUDONYM METASTAS/ WHO APPARENTLY TRIED TO 'BUY' MERTEN. A CONCILIATORY OFFER FROM THE GOVERNMENT, I.E. KARAMANLIS' PARTY, WAS BROUGHT TO MERTEN VIA ARTHUR MEISSNER OF FUERTH. ONE MICHANAKIS ALSO APPEARED ON THE SCENE. THE FOLLOWING WAS OFFERED -- REVISION OF THE VERDICT IN THE ATHENIAN LEGAL ACTION. POSSIBLY COMPENSATION.</p> <p>E. UNCLEAR CONTACTS OF MERTEN ARE,</p> <p>1. THE CONNECTION TO LAWYER DR. P. H. GORDAN OF GIESSEN, WESTANLAGE 39. THE CONNECTIONS APPEAR TO STEM FROM WORLD WAR II BUT THEY ARE UNCLEAR. BOTH HAVE SOMETHING IN COMMON.</p> <p>2. THE CONTACT WITH A FRAU MARSHALL ON 10 NOVEMBER IN MERTEN'S APARTMENT. FRAU MARSHALL BROUGHT MERTEN PAPERS, WHICH ACCORDING TO MERTEN'S STATEMENTS /COPIES OF 30 DOCUMENTS/ CONTAIN PROOF OF THE INTELLIGENCE COLLABORATION BETWEEN KONSTANTIN KARAMANLIS AND DIMITRIOS MAKRI. FRAU MARSHALL IS POSSIBLY IN CONTACT WITH POSSER AND/OR HEINEMANN AND POSSIBLY SHE ALSO HAS A DIRECT CONNECTION TO THE EAST ZONE OR OTHER EASTERN PLACES.</p> <p>2. FOR BERLIN -- UPHILL WOULD APPRECIATE A BDG CHECK ON P. H. GORDAN OF PARAGRAPH 'E' ABOVE.</p>

COPIES OF THESE WILL BE OBTAINED FROM UPHILL BUT WE ASSUME THEY WERE IN THE BATCH TRANSMITTED TO FRANKFURT WITH EGMA-66479.
