4. REPORT OF FINDINGS

On 14 May 1953 the files of 430th CIC Sub-Detachment A were examined by this Agent concerning personalities mentioned in this report, and the following information was revealed:

Serbejy Bowdij is identical with one Sergei Bowdiyi, born 26 September 1925 in Werbiwka, USSR, mentioned in Agent Report, S-15930, dated 10 December 1952, Subject, Request for Check, as residing in DP Camp Parsch, Barrack 9, Room 23, Salzburg, Land Salzburg, Austria. He is listed as an individual whose case is missing from the police files. He was screened on 14 August 1952 for employment with the Provost Marshal Office as a guard; but dismissed per action sheet dismissal, dated 14 August 1952, Ref. III2g, not subject to appeal, for having been sentenced to 1951 to seven weeks' imprisonment for unauthorized possession of weapons.

- Petro Holowinskyj is probably identical with one Peter Holowinski, born 10 April 1925 in Hohonym, Poland, the subject of a DP 48 case.
- Stepan or Stefan Bandera is mentioned in numerous reports in the files of this Sub-Detachment as a leader of a resistance group in the Ukraine.
- Josef Berest is probably identical with one Josef Berest, born 21 September 1900 in Iwow, Poland, residing at Ians 47 bei Innsbruck, Iand Tyrol, Austria, the subject of a DP 48 case.
- Stahij Koslo is identical with one Eustachius Koslo, born 17 September 1904 in Tryncza, Poland, the subject of a DP 48 case.
- Colonel Andrij Melnyk is probably identical with one Colonel Andrew Melnyk, mentioned in numerous reports in the files of this Sub-Detachment as the leader of a Soviet resistance group, the Organization of the Ukrainian Nationalists.
- Aleksender Lawryszyn is identical with one Alexander Lawryszyn, born 15 March 1903 in Bendery, Romania, the subject of a DP 48 case.
- Wolodymyr Radlowskyj is identical with one Wolodymyr Radlowskyj, born 18 December 1907 in Whyoda, Poland, residing in DP Camp Landeck, the subject of a DP 48 case.
- Dmytro Woszzak is possibly identical with one Dimitro Woszcak, born 22 October 1922 in Rowa-Ruska, Poland, the subject of a DP 48 case.

S-16671, dated 11 February 1953, Subject: Ukrainten Refugee Activities, land Salzburg, Salzburg, Austria, (Evaluation F-3), as president of UCDOA. One Demotor or Dmytro Bebrnycz, born 7 November 1887 in Synowidsko, Stryi, Poland, is the subject of a DP 48 case.
- Father Tyan Daszkowskyj may be identical with one Johannes Daschkowskyj, born 11 August 1921 in Lemberg, Poland, listed in Agent Report, S-15455, dated 14 November 1952, Subject: DP's of Soviet Nationality, as residing in Parrack 30, Room 1, DP Camp Hellbrunn, Salzburg.
- Dr. Wolodymyr Iwanowycz is probably identical with one Wolodymyr Iwanowycz, a physician, born 14 March 1905 in Topowiwci, Romania, residing in Barrack A. Room 1, DP Comp Volksgarten, Salzburg, listed in the files of this Sub-Detachment as having been screened
