1. RIEDMAYR, LFV BAVARIA, REQUESTED DEFINITIVE STATEMENT WHETHER AIS IN TOUCH WITH OR SUPPORTING BANDERA/OUN ACTIVITIES.
2. BAVARIAN GOVT WISHES TAKE ACTION WITH SUPPORT FED GOVT AGAINST BANDERA IS. ACTIVITIES. REPORTEDLY ^{in letters} MIN PRES HOEGNER TO PERSONALLY WRITE BRENTANO FOREIGN OFFICE. RIEDMAYR STATED GERHARD VON MENDE (BUERO FOR HEIMATVERTRIEBENE AUSLAENDER) HAS SUPPORTED BANDERA FOR POLITICAL REPORTS RECEIVED WHICH VON MENDE DELIVERED TO FOREIGN OFFICE. RIEDMAYR HAS IN PAST FURNISHED THAT SUPPORT TO ELEMENTS OF BANDERA UPON DIRECT REQUEST OF MENDE, I.E., EXTENSION OF RESIDENCE PERMITS. NOW MENDE REQUESTING ASSISTANCE ISSUANCE FALSE PASSPORTS AND OTHER DOCUMENTATION. THIS REQUEST TURNED DOWN AND RESULTED IN BAV DESIRE TO SOMETHING ABOUT BANDERA.
3. LFV WOULD LIKE TO INFORM MIN PRES AIS NOT INVOLVED. UPSWING REPORTEDLY NOT IN TOUCH WITH GROUP. RIEDMAYR STRONGLY SUSPECTS BRITISH TIE IN.
4. HAVE INFORMED RIEDMAYR TO BEST MY KNOWLEDGE AIS NOT INVOLVED. HE WOULD LIKE CONCLUSIVE STATEMENT. PLEASE ADVISE.

7 Sep 56. Discussed with SR-3/H-3. There has been previous correspondence on this same general subject. MUCO should have discussed this with both POB and MOB before referring it to H. KUBARK. Apparently has no interest in supporting or encouraging OUN intell activities. In fact quite the contrary. Action being taken SR-3/H-3 for reply.
