THE NAME WAS CHANGED TO ANGUITA Y TUBERT TECHNICOM ON 15 SEPTEMBER  
1955. SINCE 6 JULY 1979, THE DIRECTORS OF THE COMPANY ARE AS  
FOLLOWS: HECTOR ALFREDO ((ANGUITA)), FREDERICO ANDRES ((TUBERT)),  
ALFREDO HECTOR ((TUBERT)), JULIA ((JAITE)) DE "TUBERT", OSCAR  
EDUARDO ((TUBERT)), AND GLORIA PAULA ((TUBERT)). THE MANAGEMENT
