SON KLAUS ANTONIO BORN 9 MARCH 36. DAUGHTER ANTJE MARIA BORN 12 DEC 40. SUBJ DIVORCED IN 44. SECOND WIFE GUILIANA NEE TENDELLA, BEFORE HER MARRIAGE KNOWN FOR HER PRO YUGOSLAV-COMMUNIST SENTIMENTS.

2. PRIOR RE II SUBJ WAS LAWYER IN VIEN, DURING WAR SS MEMBER AND JUDGE IN HAGUE DURING GERMAN OCCUPATION HOLLAND. ODACID NO. 752. 7 MAY 62 FROM TEL AVIV STATES ACCORDING PRESS REPORT AUSTRIAN GOVT REQUESTED TESTIMONY ON SUBJ, FORMER NAZI WAR CRIMINAL, MEMBER EICHMANN'S DEPT AND OFFICER SS. UPON ADVISE OF COUNSEL EICHMANN DECLINED ANSWER QUESTIONS.

3. IN 49 SUBJ CAME TO ATTENTION VIEN STATE POLICE WHEN STATE-OWNED BLEIBERGER BERCKERKS UNION IN KLAGENTURT ASKED FOR BACKGROUND INFO BEFORE DOING ANY BUSINESS WITH HIM. AFTER INVESTIGATION IT DECIDED
